The General terms and conditions of the contract will be as under:-

General

1. The contract shall be for a period of one year from the date of contract unless it is curtailed or terminated by this Department owing to deficiency of service or for any other reason and breach of contract or for any other reason. The bidders shall quote comprehensive/consolidated rates for the AMC for one year with applicable taxes separately; otherwise, it will be presumed that the rates are inclusive of all applicable taxes.

2. The contract may be extendable for 3 years on same terms and conditions or with some addition/deletion/modification, mutually agreed upon by the successful service provider and the Department. However, if the services are not found satisfactory or otherwise, contract can be terminated at any time without

assigning any reason.

3. This Department reserves the right to terminate the contract during initial period also after giving a week's notice to the contracting agency, without assigning any reason.

4. The contracting Firm shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this contract to any other agency without

the prior written consent of this Department.

5. The willing firm is required to submit his previous experience of maintenance of at least 400 Computers/UPS/Printer for the last three years. Reference of satisfactory work performance from the users including three (at least) Govt Departments is also required.

6. The Firm must have valid ST/GST/PAN/TAN number and have filled IT returns preferably for the last three financial years. HP authorized Partner and ISO

Certified firm would be given preference.

7. The firms having minimum turnover of Rs 60 lakh for the last three years, and minimum 03 Years working experience with at least three Government Departments/Ministries, shall be preferred.

8. The firm also has to upload an undertaking stating that it has not been

blacklisted from any Government Ministries/Departments/PSUs.

9. The tenderer shall be bound by the details furnished to this Department while submitting the tender or at any subsequent stage. In case, any of such documents furnished by the agency/firm/company is found false at any stage, it would be deemed to be a breach of terms of contract making it liable for legal action besides termination of contract and consideration for blacklisting the firm.

10. Successful firm shall have to deposit security money of Rs. 30000/- (Thirty Thousand Only) in the form of DD/FDR in favour of DDO, DHI that would be

retained during the currency of the Contract.

Job Description and Payment :-

11. The contract will be comprehensive and the contractor would be required to

land

replace all defective parts including hard disc. The contractor would ensure that all the parts being replaced are new and genuine and of the same brand name/quality.

12. The contractor will ensure that at least two qualified Engineers having 5 years experience are always available n the Department on all working days, if required on non working days also, to attend to the complaints from the users.

- 13. All the complaints should be attended to rectify faults within one hour from the time of receipt of the complaints. In case the machine is required to be taken to the workshop for any major repair, the machine would be taken with permission, got repaired and returned to the users in the Department within 24 hours from the time of the complaint. If there is any failure on the part of the contractor, he would be liable to penal charges @ Rs. 500 per day of delay which would be deducted from the bills of the firm.
- 14. The payment will be made on quarterly basis subject to satisfactory job.

Legal ;-

- 15. Tendering agency shall be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to the Department of Heavy industry to concerned tax collection authority from time to time as per extant rules and regulations on the matter.
- 16. The Tax Deduction at Source (T.D.S) shall be deducted as per the provisions of Income Tax Department, as amended from time to time and a certificate to this effect shall be provided to the agency by this Department.
- 17.In case, the tendering agency fails to comply with any statutory/taxation liability under appropriate law, and as a result thereof the Department is put to any loss/obligation, monetary or otherwise, the Department will be entitled to make deduction from the outstanding bills or the performance Security Deposit of the agency, to the extent of the loss or obligation in monitory terms.
- 18.In case of breach of any terms and conditions attached to this Contract, the Performance Security Deposit of the agency will be liable to be forfeited by this Department besides termination of contract and consideration for blacklisting the firm.
- 19. This Department reserves the right to withdraw/relax/modify any of the terms and condition mentioned above so as to overcome the problem encountered at a later stage.
- 20. This Department shall not be responsible for any financial loss or other injury to any person deployed by service providing agency in the course of their performing the functions/duties, or for payment towards any compensation.

21. All disputes arising out of Contract shall be subjected to the jurisdiction of Delhi Courts only.
