- 2. The terms and conditions of the contract will be as under:
- a) The contract is valid initially for a period of one (1) year w.e.f. 23.12.2015 which is extendable upto three (3) years; however if the services are found not satisfactory the contract may be terminated at any time without assigning any reason.
