





Terms & Conditions for supply/hire of potted decorative foliage plants and regular periodic supply of cut flowers with flowers pots in the Department of Heavy Industry.


- i) The bidder should have previous experience of providing satisfactory at least two Govt. Deptts./PSUs.
- ii) In the tender offer, the name/kind/ size of indoor decorative foliage plant and cut flowers should be clearly indicated along with the rates for their supply.
- iii) The rates for supply should be quoted on monthly basis. As regard the cut flowers, the monthly rates for supply on daily basis as well as on alternative days basis should be indicated separately.
- iv) The potted decorative doors plants would be watered/maintained regularly by the Supplier on daily basis to always give it a beautiful and fresh look. Any violation of this condition would be treated as breach of contract.
- v) The indoor plant would be replaced as soon as they outlive their indoor life.
- vi) The indoor decorative plants supplied would be replaced every month with a different variety.
- vii) For the cut flowers, beautiful flower pots including mounting pins etc. would be provided by the supplier free of cost during the tenure of the contract.
- viii) The contractor will have to deposit ₹10,000/- in advance as security deposit in the form of pay order/DD/FDR to be retained during the currency of the contract would get converted into part security deposit and he will have to deposit the balance of ₹5000/- as security deposit.
- ix) The department is not bound to accept the lowest rate and reserves the right to reject any/all offers without assigning reasons.
