Parmar, Economic Adviser at New Delhi.

And whereas vide Memorandum No. A-19011/1/2012-Admn dated August 14, 2014 (copy enclosed as A-1) in paragraph 3, Shri Ram Chandra Jha, Retd., Deputy Director (Official Language), Department of Heavy Industry, M/o Heavy Industries & Public Enterprises was given an opportunity to submit within 10 days a written statement of his defence and also state whether he desires to be heard in person.

And whereas vide No. A-19011/1/2012-Admn dated November 7, 2014 (copy enclosed as A-2) an inquiry under Rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, is being held against Shri Ram Chandra Jha, Retd., Deputy Director (Official Language), Department of Heavy Industry, M/o Heavy Industries & Public Enterprises by Shri R.K. Parmar, Economic Adviser at New Delhi.

And whereas an opportunity of hearing was given to you - Shri Ram Chandra Jha, Retd., Deputy Director (Official Language), Department of Heavy Industry, M/o Heavy Industries & Public Enterprises to submit a written reply of your defence on January 12, 2015 vide OM No.455/EA(RKP)/2014(E-12945) dated December 23, 2014 delivered at your address by speed post (copy of letter and speed post tracking as A-3). The said opportunity was, however, not exercised by you nor was any information received from you.
6. And whereas another opportunity of hearing, being the last opportunity is given to you - Shri Ram Chandra Jha, Retd., Deputy Director (Official Language), Department of Heavy Industry, M/o Heavy Industries & Public Enterprises to submit a written reply of your defence by February 2, 2015 and to appear in person to examine the evidence and cross examine the witnesses. The said opportunity is to be exercised in the office of Economic Adviser & Inquiry Authority, R.No. 124, Udyog Bhavan, New Delhi - at 10.30 AM on February 2, 2015.
7. The said opportunity is the last opportunity after which the matter will be decided *ex-parte*.



Shri Jha is further informed that if he does not submit his written statement of defence on or before the date specified in Para 3 above, or does not appear in person before the inquiring authority or otherwise fails or refuses to comply with the provisions of Rule 14 of and Rule 15 of CCS (CCA) Rules, 1965, or the orders/directions issued in pursuance of the said rules, the enquiring authority may hold the inquiry against him ex-parte.
