ORDER

Subject : Public Procurement (Preference to Make in India) Order, 2017 – notifying Minimum Local Content in Goods/Services for procurement and manufacturing of Industrial Boilers (Steam Generators)-Revision.

In pursuance of the Public Procurement (Preference to Make in India)(PPP-MII) Order 2017 notified vide the Department For Promotion Of Industry And Internal Trade(DPIIT) Notification No. 45021/2/2017-PP(B.E.II) dated 15.06.2017 and subsequent amendments dated 28.05.2018, 29.05.2019 and 04.06.2020, and in supersession of the afore mentioned PPP-MII Order for Industrial Boiler notification No. 16(4)/2018-HEI -(Part-1) dated 16 January 2020, to promote manufacturing and production of goods and services in India to enhance income and employment, it has been decided that preference shall be given to domestically manufactured Industrial Boilers (Steam Generators) by all public procuring entities as defined under the DPIIT's PPP-MII Order Notification No. 45021/2/2017-PP (BE-II) dated 4th June 2020.

2. Further, it is clarified that this Order is also applicable for all Central Schemes (CS)/Central Sector Scheme (CSS) for which procurement is made by States and Local Bodies, if that project / scheme is fully / partly funded by Government of India in respect of manufacturing of Industrial Boilers (Steam Generators).

3. In furtherance of the aforesaid PPP-MII, Order(s) of DPIIT and in consultation with the stakeholders for the items associated with manufacturing and services of Industrial Boilers (Steam Generators), Department of Heavy Industry, Ministry of Heavy Industries & Public Enterprises hereby notifies the status of sufficient local capacity and competition, for procurement of Industrial Boiler/it's such items (as under)

by procuring entities which shall be in accordance with the Clause 3 of DPIIT's PPP-MII Order Notification No. 45021/2/2017-PP (BE-II) dated 4th June 2020.
