#### I. COMPANY PROFILE

Andrew Yule & Company Limited (AYCL) is engaged in the manufacture, sales and servicing of various industrial products i.e. Industrial Fans, Tea Machinery, Air Pollution Control Equipment, Switchgear, Circuit Breakers, Transformer and various other electrical equipments.
