
This Ministry intends to dispose off the stock of the items (list attached) of obsolete & unserviceable articles, on as is where is basis.

You are requested to submit your quotations for these items along with a demand draft of Rs. 10,000/- as earnest money, drawn in favour of DDO, Department of Heavy Industry, latest by the 18th July, 2011 by 3.30 P.M. in sealed cover addressed to the undersigned i.e. Under Secretary, GA, Section, Deptt. of Heavy Industry, Room No. 15, Udyog Bhawan, New Delhi. Quotation received after stipulated date/time shall not be entertained. The rates must be quoted as lump-sum basis. Rates quoted for partly items will not be accepted. The interested parties may contact for inspection of the items on all working days upto 18th July, 2011 between 2.00 pm to 3.00 pm.

3. The quotations will be opened in the presence of the bidders on 18th July, 2010 itself at 4.00 p.m. in room No. 15, Udyog Bhawan, New Delhi. The bidder will be selected on the basis of the highest bid. The successful bidder will be required to deposit the full amount in cash or submit a demand draft in favour of the DDO, Deptt. of Heavy Industry within 2 working days. The material must be taken out immediately within 3 days from date of deposit of money.

4. The Ministry reserves the right of rejecting the any or all quotations without assigning any reason thereof at any time. The demand draft (earnest money) will be returned to the unsuccessful bidders immediately after finalization of proceedings. In the event of any successful bidder failing to submit the demand draft for the entire amount of the articles and lift the items mentioned at para 3 above within stipulate period, the earnest money deposit of Rs. 10,000/- will stand forfeited.

5. The rates for total items (as is where is basis) should be indicated and no separate rate for individual item should be quoted.
