National Automotive Board (NAB) is an autonomous society under Department of Heavy Industry, Ministry of Heavy Industry & Public enterprises, Govt. of India. The main objective of NAB is to steer, coordinate and synergize all efforts of the government in important ongoing and new initiatives for automotive sector especially in the area of electric mobility, intelligent transport systems, automotive testing, collaborative R&D and for implementation of the recommendations of the Automotive Mission Plan 2006-16. It works as nerve centre of the organizational interactions between the government, industry and the academia, and, under DHI, is function as a repository of automotive domain expertise.

Application is invited for the post of Member (R&D), National Automotive Board (NAB). The details pay scale, qualification, experience, job responsibility, age limit etc for the post are as follows-

Details of the post of Member (R&D), National Automotive Board (NAB)

Designation: Member (R&D), NAB

Location: New Delhi

Category: Senior level

Pay Scale: Pay Band -4 (Rs. 37400-67000)+Grade pay Rs.10000

Nature of Appointment:

- Only "Indian Citizens" is eligible to apply.
- In case of officers on deputation from Government the tenure will be for 3 years extendable to 5 years based on performance.
- For officers joining on absorption the tenure will be till attaining age of retirement (60 years).

The post will be filled on deputation basis of suitable eligible officers from Govt. of India. However, the preference will be given to suitable Govt. officer willing to join on absorption to NAB.

Age Limit:- Minimum age- 42 years and Maximum age- 52 years. The age of retirement is 60 years.

QUALIFICATION & EXPERIANCE

The incumbent should be regular scnior Govt. officer working either in the pay band PB-4 (37400-67000) + Grade pay Rs.10000 or in the pay band PB-4 (37400-67000) + Grade pay Rs. 8700/8900 with an experience of at least 5 years in the GP Rs.8700/8900.

Educational Qualification: The incumbent should have a Master's degree in Science or Engineering with good academic record from a reputed university / institution. Phd in relevant field is desirable.

Experience:

The following experience is desirable:

- Should be well versed with the policy environment of automotive sector in the country.
- Should have minimum 10 years' experience in R&D policy.
- Should have strong technology foresight capabilities and a good knowledge of the automotive R&D landscape in India and abroad.
- Extensive experience in formulating R&D project proposals.
- Capabilities and experience in creating and managing R&D consortia projects.
- Should have good understanding of the R&D policy framework of the Government and good networking capabilities, leadership qualities.
- Preferably have good past exp. of managing automotive R&D projects/progammes.

Job Responsibility:

- Member, R&D, NAB shall head the Research and Development (R&D) division in NAB.
 He / She will be responsible for all matters relating to R&D activities taken up under the NAB framework.
- He / She will be responsible for setting the R&D vision & roadmap for NAB. This will include activities related to technology foresight, designing and finalizing the R&D plan for NAB as a whole.
- He / She shall also lead the team that will develop individual R&D proposals (DPRs) on behalf of NAB framework, present these to funding agencies and obtain approvals. The R&D project/progams implementation supervision, project monitoring and reporting of the outcomes of the R&D projects will also be supervised by Member, R&D.
- He / She shall help develop the R&D plans of NAB centres, monitor the progress of various R&D projects and help maintain coordination & synergy amongst the R&D efforts of various NAB centres. He /She shall also plan NAB R&D efforts in a manner that ensures maximization of use of facilities, expertise and resources available in the various test centres under NAB.
- He / She shall assist the Chairman, NAB in extending support to the various Government Departments, including DHI for meeting their requirements related to automotive R&D. This will include helping DHI in effectively managing the R&D projects/programme sponsored by automotive Cess funds.
- He / She shall advice and assist Chairman, NAB in R&D related capacity building efforts for the NAB centres.
- He / She shall plan and formulate consortia based R&D projects/programme involving the facilities available under NAB framework (centres under NAB) and also by partnering with outside research facilities and with active involvement of industry and academia.
- He /She shall be responsible for securing consortia based R&D projects from Industry to be taken up by NAB.

- He / She shall assist in building R&D networks with academia and for generation, management & protection of IPRS.
- He / She shall advice the Chairman, NAB on the future expansion, upgradation and capacity building of testing centres under NAB from a R&D perspective.
- He / She shall assist Chairman, NAB for ensuring a framework of cooperation amongst the various testing centres under NAB.
- He / She shall provide technical advice and expertise as required from time to time in matters referred to NAB by various Govt. Ministries/agencies.
- He / She shall also be responsible for the supervision of activities & coordination of issues with all centres under NAB in matters related to R&D activities.
- He / She shall provide support to other nodal divisions of NAB for the activities related to R&D that are associated with any other program / new initiative of NAB being dealt by them.
- He / She shall provide inputs to the nodal division on skill development for skill development efforts related to automotive R&D requirements.
- He / She shall also assist Chairman, NAB in matters related to automotive regulations.
- He / She will carry out any other responsibilities or tasks that are assigned to him/her by Chairman, NAB and shall represent NAB in any meetings or committees or export bodies as decided from time to time.
- Member, R&D may assign/transfer/delegate any departmental function and the duties of technical nature to any employee of the Society, as he/she may deem fit and proper and necessary.
