- 2. Additional Secretary & Financial Adviser, DHI alongwith senior officer of DHI attended the meeting of Department related Parliamentary Standing Committee (DRPSC) on Industry on 26th April, 2017 in Parliament House Annexe to discuss the issue of timebound disposal of land of CPSEs due for closure / strategic sale and utilization of proceeds of sale with particular references to CPSEs under DHI.
