Dear Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Department of Heavy Industry (DHI) for the month of August, 2020 are highlighted:

- 1. I chaired the 4<sup>th</sup> meeting of Project Implementation and Sanctioning Committee (PISC) under FAME India Scheme Phase II wherein it was decided to sanction 670 e-buses and 241 Charging Stations to 7 cities.
- 2. "Indo-Japan Webinar on Electric Vehicle Sector: Challenges & Emerging Opportunities" was organized along with Embassy of India on 5<sup>th</sup> August, 2020 to showcase Govt. Policies and programmes in the field of Electric Vehicles and identify areas of cooperation in the spheres of R&D and Manufacturing of Electric Vehicles (EVs), EV components and Advanced Chemistry Cells (ACC). The Webinar was attended by leading OEMs from Japan as well as from India.
- 3. A meeting was held with representatives of State Govt./STUs/CTUs and OEMs of electric buses on 6<sup>th</sup> Aug, 2020 to expedite deployment of electric buses as sanctioned under FAME-II.
- 4. Letters of Award were issued for 108 Charging Stations (37 in Bhopal, 29 in Gangtok, 25 in Kanpur and 17 in Shillong) as sanctioned under Fame-II.
- 5. The first tranche of incentive was released for deployment of 90 Electric Buses (50 in the city of New Town Kolkata and 40 in the city of Nagpur) as sanctioned under FAME-II.
- 6. On 14.08.2020, I met the CEOs of Plastic Machinery Manufacturers Association of India (PMMAI) with the objective of listening to their concerns and resolving issues, The Department shall facilitate easing the bottlenecks they face.
- 7. Project Development Cell has been set up in the Department. For attracting & facilitating investments in the Auto sector, meetings have been held with several potential investors in the sector including Yazaki Corporation, Bahwan International, Daicel Corporation, Skoda Auto, Toyota Tsuho and CKD Corporation
- 8. To harness new opportunities for the company due to possible shifts in global supply chains after COVID-19 pandemic, and the Hon'ble Prime Minister's call for 'Atmanirbhar Bharat', a new business group 'Make in India Business Development Group' has been formed at BHEL. The vertical is charged with the responsibility of identifying products currently being imported by the company as well as the country and which can be developed/ manufactured by BHEL. Identifying opportunities for increased in-house manufacturing in the company and working with global OEM's for 'Make in India, Make for the World', will enable BHEL to improve its plant capacity utilization.

- 9. The EOI released by BHEL in April 2020 for inviting Global OEMs to partner with BHEL for setting up or expanding their manufacturing operations in India resulted in signing of three MoU's in August 2020:
  - SwissRapide, Switzerland: for cooperation targeting upcoming Mumbai & Bengaluru Maglev Train projects.
  - o Zorya, Ukraine: for Marine Gas Turbines & Gear Boxes for Defence applications.
  - o Cambli, Canada: for Armored Trucks equipped with smart technologies.
- 10. I reviewed the performance of all operational CPSEs and Autonomous Bodies under DHI on 7 August, 2020.
- 11. Swatchata Pakhwada was celebrated in DHI from 16<sup>th</sup> August, 2020 to 31<sup>st</sup> August, 2020.
- 12. All the 14 Townships of BHEL are now 'Single Use Plastic free' zone after audit by M/s Bureau Veritas (India) Pvt. Ltd.
- 13. In view of the Cabinet Secretariat's direction dated 12-01-2017 vide D.O letter No.1/50/1/2017-Cab, the status of ACC directions/ orders as per the prescribed format are given as under:
