MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR AUGUST, 2017

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of August, 2017 in the Department of Heavy Industry (DHI).

1. In the context of bringing out a new auto policy, a consultation meeting was held with stakeholders.
2. A total of 11 proposals for financial assistance worth Rs 169 crore were sanctioned under the Scheme for Enhancement of Competitiveness in the Indian Capital Goods Sector.
3. A Common Engineering Facility Center (CEFC) on Industry 4.0 of M/s Automation Association of India and IIT Delhi was inaugurated.
4. The Inter Ministerial Group (IMG) to consider issues regarding payment of outstanding fiscal incentives under the MoU between Government of Tamil Nadu (GoTN) and R&N Consortium met to consider the progress and issues.
5. As per directions of the Cabinet Secretariat, the 64th Governing Council meeting of NATIS decided to invite Expressions of Interest from prospective Consultants (Transaction Advisors) to advise NATRIP on PPP in its centers i.e., ICAT/ Manesar, GARC/ Chennai, NATRAX/ Indore and NIAIMT/ Silchar, who would also be engaged in making out the RFP documents and assist in finalization of the PPP partner(s) while also ensuring smooth transition through the first two years. NATRIP has floated the E01 on 18th August, 2017.
6. Bharat Heavy Electricals Ltd. (BHEL), a CPSE under this Department has successfully commissioned the first unit of 2x30 MW Turrial Hydro Electric Project (HER) in Mizoram. Significantly, this is the first large rating hydro power project in the state of Mizoram.
7. For the first quarter of FY 2017-18, Bharat Heavy Electricals Ltd. (BHEL) reported a turnover of Rs 5607 crore with a profit before tax (PAT) of Rs. 108 crore. BHEL has achieved provisional turnover of INR 8,776 crore upto August, 2017 including INR 1825 crore during the month.
8. The Board of Directors of BHEL at its meeting held on 10th August, 2017, has recommended the issue of bonus shares in the ratio of 1 bonus shares of Rs 2 against 2 existing equity shares of Rs 2, subject to approval of shareholders.
9. BHEL developed a knowledge-based troubleshooting mobile app to minimize the time for troubleshooting of issues faced at site during erection and commissioning.
