- f) You are requested to deposit Rs. 10,000/- only in advance as security deposit in the form of a DD/FDR in favour of DDO, DHI to be retained during the currency of the contract.
- g) All the items /spares to be supplied should be of original make failing which the contract will be terminated & the security deposit forfeited and other legal action will be taken accordingly against the firm.

The contract will be started on acceptance of the above terms and conditions and deposition of Security amount of Rs. 10,000/- with the Department.
