



Each entity shall install at least one charging station at every 25 kms on both sides of the Highway and also atleast one Charging Station for Long Range/Heavy Duty EVs at every 100 kms on both sides of the Highway, in accordance with the Ministry of Power's revised guidelines/standards for charging infrastructure for Electric Vehicles (EVs), dated 01st October, 2019. Relaxation to this clause will be given in respect of closed highways or elevated highways/expressways, where the entity will be required to install at least 4 charging stations for every 100 kms on both sides of the Highway and also atleast one Charging Station for Long Range/Heavy Duty EVs at every 100 kms on both sides of the Highway. However, preference will be given for the proposals which offer at least one charging station at every 25 kms on both sides of the Highway and also atleast one Charging Station for Long Range/Heavy Duty EVs at every 100 kms on both sides of the Highway
