With reference to D.O. letter No.502/1/2/2014-CA-V dated 5th August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of August, 2022 are highlighted:

- 1. Hon'ble Prime Minister of India addressed the programme marking commemoration of 40 years of Suzuki in India, held at Mahatma Mandir, Gandhinagar on 28th August, 2022. He also laid the foundation stones of two key projects of the Suzuki group in India the Suzuki Motor Gujarat Electric Vehicle Battery Manufacturing Facility at Hansalpur, Gujarat and Maruti Suzuki's upcoming vehicle manufacturing facility in Kharkhoda, Haryana.
- 2. The Revival and Mill Development Plan (RMDP) of Nepa Ltd., as approved by CCEA on 3rd October, 2018, has since been completed. The plant post RMDP was inaugurated on 22nd August, 2022 by Dr. Mahendra Nath Pandey, Hon'ble Minister of Heavy Industries.
- 3. MHI launched Automated Online Data Transfer for capturing critical data related to Domestic Value Addition (DVA) from the PLI applicant's ERP (Enterprise Resource Planning) system to PLI Auto Portal on 11th August, 2022. The IT enabled system has been devised to enable smooth transfer of data from applicant's existing ERP system to PLI Auto portal of MHI in safe environment. The Application Programming Interface (API) will get embedded with ERP system of the applicant and will enable automaticity and paperless processing in this scheme. This facility eliminates voluminous paper work by bringing in automation. This IT enabled system will reduce compliance burden on the part of the applicants on the one hand and will enable faster processing of claim on the other hand. The initiative taken by MHI will be an important step in enabling transparency, ease of doing business, faceless and self-certification based assessment and paperless delivery. With this IT enabled system, Hon'ble Prime Minister's 'Make in India' and 'Atma Nirbhar Bharat' campaign will get a major boost.
- 4. Under PLI of Advance Chemistry Cell (ACC), after successful signing of the Program Agreement, the selected bidders have submitted the Performance Bank Guarantee within the specified timelines.

- 5. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In August, 2022, a total of 276 GST Concession Certificates have been issued.
- 6. 'Har Ghar Tiranga' programme was celebrated successfully by MHI and its Central Public Sector Enterprises (CPSEs) / Autonomous Bodies (ABs) during 13th August 15th August, 2022 with great enthusiasm and fervour.
- 7. The Swachhta Pakhwada 2022 was observed successfully by MHI and its Central Public Sector Enterprises (CPSEs) & Autonomous Bodies from 16th August, 2022 to 31st August, 2022.
- 8. BHEL has signed Memorandum of Understanding with Rail Vikas Nigam Ltd. (RVNL) on 26th August, 2022 to jointly work in the field of infrastructure and project execution, in India and abroad.
