# MINUTES OF THE MEETING OF THE DEVELOPMENT COUNCIL FOR AUTOMOBILE AND ALLIED INDUSTRIES (DCAAI) HELD ON 27<sup>TH</sup> JANUARY 2016

The meeting of the Development Council for Automobile and Allied Industries was held at 3 PM on 27<sup>th</sup> January 2016 at Udyog Bhawan under the chairmanship of Secretary (Heavy Industry). The list of participants is annexed.

2. At the outset, Joint Secretary (Auto)/Member Secretary welcomed all members of the Development Council present in the meeting followed by briefing on the background & functions of the Development Council and about the agenda of the meeting i.e. Discussion on finalisation of AMP 2016-26. Joint Secretary (Auto) / Member Secretary thereafter requested Secretary (Heavy Industry)/Chairman to allow for proceeding with the agenda of the meeting.

3. While welcoming all members of the Council present in the meeting, the Chairman/SHI asked the representative from iMaCS to make a brief presentation on AMP 2016-26. Shri R. Raghuttama Rao from iMaCS then made a presentation starting from Learning from previous AMP 2006-16 to Vision/Objective/Salient features of AMP 2016-26.

4. Chairman, DCAAI / Secretary (HI) thereafter invited suggestions/views on the Draft AMP 2016-2026 from all members present in the meeting, which are summarised hereunder:-

- 1) ARAI expressed their agreement with the provisions of AMP 2016-26.
- ACMA in principle agreed to the adoption of AMP 2016-26 while making following observations –
  - a) Review of High Import Duty on Raw Materials; &
  - b) Inclusion of summary sheet in the Plan highlighting Turnover/Import-Export etc. of the Industry
- 3) Department of Commerce made certain observation on the draft stating that the words "The Govt. shall engage ...." Should be replaced by "Industry should engage....". They also mentioned about the duty structure of Steel Products as well as of FTAs.

- 4) There are suggestions for incorporating provisions regarding Mid-Term Appraisals in the Plan and for Implementation of the Plan in a phased manner.
- 5) JS(Transport), MoRTH expressed some concern over the plan mentioning that it is more of Consumer Driven and so required a re-look to make it more challenging. Also expressed concern over such a high target of job creation. Suggested for focus on R&D facilitations with incentivising.
- 6) CEO, NATRIP expressed their agreement with the AMP 2016-26.
- 7) All other Industry representatives in the Council present in the meeting in principle agreed to the provisions of AMP 2016-26.

5. Chairman, DCAAI / Secretary (HI) observed that all suggestions of the members present in the meeting are well taken and would be taken care of in finalized Automotive Mission Plan 2016-26. He further observed that the representative of iMaCS would be in touch with JS (Transport), MoRTH for finalising the Plan. Accordingly the draft AMP 2016-2026 discussed in the meeting was, in principle, approved by the Development Council with suggested observations of the members detailed in the foregoing paragraph.

6. Meeting ended with vote of thanks to the chair.
