## MONTHLY SUMMARY FOR DECEMBER, 2015

- i. MoU signed for Development of National Institute of Manufacturing Technology: An MoU was signed by Secretary (Heavy Industry) and Secretary (MSDE), in presence of Shri Anant Geete, Hon'ble Union Minister for Heavy Industries & Public Enterprises and Shri Rajiv Pratap Rudy, Hon'ble Minister of State for Skill Development and Entrepreneurship on 8th December, 2015 for development of a Multi-location, National Institute of Manufacturing Technology (NIMT) for training, education and research in manufacturing technologies by leveraging the infrastructure and facilities of PSUs under Department of Heavy Industry.
- ii. Hosting of WIN India, advanced manufacturing technologies Trade Fair: Department of Heavy Industry co-hosted WIN India, an advanced manufacturing technologies Trade Fair organized by M/s Hannover Milano Fairs India Limited, held from December 9-11, 2015 at New Delhi. It served as an important platform for showcasing global technologies, advanced manufacturing and creating opportunities for technological collaborations. Hon'ble Minister for HI&PE, Shri Anant Geete inaugurated the Fair in the presence of Ms. Daniela Behrens, State Secretary, Ministry of Economic Affairs, Labour & Transport of Federal State of Niedersachsen, Federal Republic of Germany.
- iii. WIN-India 2015 Show: As a part of WIN-India 2015, a CEO Round Table was hosted by DHI on 9th December, 2015 wherein along with Secretary, HI and Principal Scientific Adviser to PM, Commerce Secretary, Member (CBEC), CEOs from Departmental CPSEs, HEC, HMT, REIL and BHEL and from Private Sector (like L&T, Alstom, Schneider Electric) as well as Industry Associations (like IEEMA, IMTMA, TAGMA and FICCI) participated. During the Round Table, key issues affecting domestic capital goods industry were discussed and several suggestions emanated from the meeting for development of the domestic capital goods industry
- iv. National Capital Goods Policy: The Draft National Capital Goods Policy was reviewed by Principal Secretary to PM on 10th December, 2015. The Draft Cabinet Note on the Capital Goods Policy has since been circulated for Inter-Ministerial consultation.
- v. Review of the MoU between M/s. Fraunhofer Germany & DHI by Cabinet: Cabinet in its meeting on 2nd December, 2015 took note of the MoU between M/s. Fraunhofer Germany & DHI for technological co-operation in the field of manufacturing.

- vi. Meeting with Transport Ministers of all State Governments/ UTs: A meeting was held under the Chairmanship of Hon'ble Minister (HI&PE) with the Transport Ministers of all State Governments/UTs on 9th December, 2015 to involve the States on supporting Electric Mobility and to encourage implementation of FAME India-Scheme in States/UTs.
- vii. FAME India Eco Drive- Road Rally: A FAME- India Eco Drive- Road Rally was organized in Chandigarh on 7th December, 2015 for promotion of hybrid and electric vehicles in the country.
- viii. Meeting of Project Implementation and Sanctioning Committee: The 3rd Meeting of Project Implementation and Sanctioning Committee for the Scheme on Electrical Mobility was held under the Chairmanship of Secretary (HI) on 4th December, 2015, at Udyog Bhawan, New Delhi.
- ix. Violation of emission norms by Volkswagen: A meeting was held by DHI with ARAI and M/s Volkswagen India on 1st December, 2015 to discuss the issues regarding alleged violation of emission norms by Volkswagen. Volkswagen informed that they are recalling about 2,23,500 vehicles of the Company. A report on the matter has been sent to the regulatory ministry i.e. Ministry of Road Transport & Highways.
- x. Closure of Tungabhadra Steel Plant Limited: Cabinet Committee on Economic Affairs in its meeting on 22nd December, 2015 approved closure of Tungabhadra Steel Plant Limited, Hospet, Karnataka with an attractive Voluntary Retirement Scheme/Voluntary Separation Scheme/Package for their employees, disposal of movable/immovable assets and liquidation of outstanding liabilities.
- xi MoU between Heavy Engineering Corporation, a CPSE under DHI and CNIITMASH, Russian Company: Heavy Engineering Corporation, (HEC) signed an MoU with a Russian company CNIITMASH, a pioneer in steel manufacturing industry, for transfer of latest technology to HEC. The MoU was signed on 24th December, 2015 in Moscow, Russia during the visit of Hon'ble Prime Minister. HEC signed another MoU with CNIITMASH on the same occasion for setting up a "Centre of Excellence in Design" in Heavy Engineering Technologies. This would be the first ever such Design Centre in the country.
  - xii Grant of capital subsidy of 40% under National Clean Energy Fund (NCEF): Principal Secretary to PM took a meeting on 14th December, 2015 on the proposal of this Department for grant of capital subsidy of 40% under National

Clean Energy Fund (NCEF) for setting up of 480 MW Integrated Solar PV manufacturing facility by BHEL at Bhandara, Maharashtra. In the meeting, it was decided that the proposal shall be favorably considered by Ministry of New & Renewable Energy and final CCEA Note may be immediately circulated by this Department for the purpose.

xiii Settlement of the legal dispute between Brahmaputra Chemicals & Polymers Limited (BCPL) and Engineering Projects (India) Limited (EPIL): An out of Court settlement of the long standing legal dispute between Brahmaputra Chemicals & Polymers Limited (BCPL) and Engineering Projects (India) Limited (EPIL) has been reached as a result of consultation meetings between DHI and Department of Chemicals & Petrochemicals on 2 Contracts i.e. Plant & Buildings (approx. Rs. 84 crore) and Site Grading Works (approx. Rs. 43 crore). The dispute had arisen due to perceived violation of contract leading to protracted litigation between the two PSUs. It was agreed at the meeting held on 22nd December, 2015 between Secretary, DHI, and Secretary, Chemicals & Petrochemicals that both the CPSEs would bring about withdrawal of all court cases, upon release of the proceeds & BGs
