MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR DECEMBER, 2017

This has reference to Cabinet Secretariat's DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of December, 2017 in the Department of Heavy Industry (DHI).

1. "Swachhata Pakhwada" was observed in DHI during the period from 16/12/2017 to 31/12/2017. To sensitise the CPSEs/Autonomous Bodies under DHI, of the national importance of the Swachhata Pakhwada, Secretary (HI) had a pre-Pakhwada interaction with CMDs/CEOs/MDs on 14/12/2017 to review the preparedness of the organizations and for encouraging them to take up activities for creation of partnerships in waste management and segregation, promotion of waste recycling and disposal of old stores. Swachhata activities were undertaken with great enthusiasm with the involvement of community and students through the organisation of workshops/meetings/competitions for creating awareness about Swachhata and were also featured on the social media. A highlight of the Swachhata Pakhwara for DHI was the announcement by the Hon'ble Minister (HI&PE) in a Press Conference on 27.12.17 of the cities selected under the Eol issued for promotion of public and shared e-mobility under FAME scheme.

- 2. Under the above mentioned Eol, 11 cities namely, Delhi, Mumbai, Kolkata, Jaipur, Lucknow, Indore, Ahmedabad, Bengaluru, Hyderabad, Guwahati and Jammu were selected in a keen contest involving 44 applicant cities across 21 states on the basis of well defined objective criteria. A total of 390 E-buses, 370 e-four wheeler taxis and 720 e-three wheeler autos have been approved, along with requisite charging infrastructure, with an expected spend of approximately Rs.437 crores to be incurred over the next year or so. With this the entire resource envelope of the present FAME scheme would be exhausted.
- 3. The ninth meeting of Inter-Ministerial Group (IMG) to discuss issues regarding international arbitration proceedings between Nissan Motors Ltd. and the Republic of India under Comprehensive Economic Partnership Agreement (CEPA) with Japan was held on 12th December, 2017. Govt. of Tamil Nadu had filed an anti-suit injunction in the Madras High Court challenging the legitimacy of the arbitration proceedings. The Hon'ble Court had sought to hear the GOI in the matter. The IMG decided that the anti-suit injunction could not be supported by GoI as it would need to honour its commitments under CEPA. This stand was apprised to Principal Secretary to PM and, as per his directions, it was further discussed by SHI with the MoS, Law & Justice, Shri P.P. Chaudhary. Subsequently, an affidavit vetted by the Attorney General (AG) was filed in the Madras High Court on these lines.

- The Committee on Public Undertakings took evidence of DHI for their report on "Review of Loss Making CPSEs" on 7th December, 2017.
- 5 . A Note for Cabinet Committee on Economic Affairs (CCEA) on salary support and revival of Nepa Limited has been circulated on 11th December, 2017 for inter-ministerial consultations. Final Cabinet Note on disposal of immovable assets of Tungabhadra Steel Products Ltd. and getting the name of this company struck off form the Register of companies after settling its balance liabilities was sent to Cabinet Secretariat on 20th December, 2017 for consideration of the Cabinet.
- 6 . An MOU was signed between DHI and the SPV formed by M/s Kirloskar CSR foundation with an objective to establish a world class centre for promoting innovation & adoption of Industry 4.0 solutions to make Indian Industries, especially MSMEs, globally competitive and to promote development of relevant skills and low cost innovations.
- 7. Three meetings were held in PMO under the Chairmanship of Principal Secretary to PM:
 - To review the progress of closure of CPSEs under DHI. Follow up actions to the decisions of the meeting are being pursued by DHI.
 - ii. In a meeting held on 23rd December, 2017 regarding surplus land issues of HMT Ltd. with Secretary (HI) and Chief Secretary, Govt. of Haryana it was decided to expedite the transfer of surplus land of HMT Ltd. to Govt. of Haryana at mutually agreed compensation and to withdraw all litigation relating to land.
 - iii. In a meeting on the Cabinet Note of DHI on modernization and revival plan of Heavy Engineering Corporation (HEC) Limited, directions were issued for strategic disinvestment of HEC.
 - Bharat Heavy Electricals Ltd. secured a contract from Rail Coach Factory, Kapurthala amounting to Rs. 672 crore for 146 sets of IGBT-based 3-phase electrics for 25 KV AC Mainline EMU trains.
