

Eligibility criteria for the Post of Director (Infrastructure) to be filed on Deputation.

1. Post, Pay Scale & Nature of Appointment

Designation: Director Infrastructure | Number of the post: 1

Nature of Appointment

Period of Deputation likely to be Project duration, i.e. 31st December 2017 or further extend if project is extended further.

2. Academic Qualification for incumbents competencies /skill

Essential Qualification

B.E/ B-Tech in Civil Engineering with good academic record from a recognized university/institution or equivalent.

Desirable Qualification

- i. Candidate with sound managerial and technical skills with experience of setting up the automobile/ automotive component plants/ automotive testing facilities/ highways/ tracks etc or large transport infrastructure facilities would have an added advantage.
- ii. MBA for recognized university/ institution or equivalent.

Government Deputation:

- i. Candidate coming from Government deputation should be in analogous posts or in the pay level -13A or 13 (as per 7th Pay Matrix) at least two years.
- ii. B.E./B-Tech in Civil Engineering with good academic record from a recognized university/ institution or equivalent.

3. Age limit

Not above 52 years- The age limit would be relaxed by 3 years in exceptionally deserving cases.

4. Post qualification Experience

Essential

- i. At least 15 years of experience out of which at least three years heading the large infrastructure and turnkey project having interface with experts of international repute.
- ii. Should have aptitude for planning, design co-ordination, execution and monitoring of large infrastructure projects having various multi disciplinary interface and should have established himself with proven qualities of leadership in the implementation of turnkey project.
- iii. He/ She should be very strong in project planning, facility layouts, utilities' planning and should have wide ranging skills for negotiations with suppliers of equipments

Desirable

- i. 20 years of experience out of which at least three years heading the large infrastructure and turnkey project having interface with experts of international repute.
- ii. Formulation, implementation, monitoring and control of projects in Automobile sector.



5. Mode of Recruitment / Probation period/confirmation of Service

- i. Only "Indian Citizens" shall be eligible to apply
- ii. Job description and candidate's qualification and experience shall be the parameters for selection the candidate

Government Deputation

Deputation includes deputation from Central/ State Government/PSU's/ large Government infrastructure projects initially for a project period or period three years whichever is earlier and can be extended as per requirement.

Internal Candidate

Suitable internal candidates in the rank of Additional Director/ Deputy Director may also apply against this post and shall be given appropriate weightage as approved.

6. Job Responsibility

- i. Planning, Designing, Execution and Monitoring of the entire Project Infrastructure.
- ii. Heading the core infrastructure team of NATRIP for comprehensive and organized implementation of the project.
- iii. Defining the entire infrastructural architecture of the testing and R&D facilities spread across seven location of NATRIP, in close coordination with Director (Technical)
- iv. Coordination the infrastructural aspects with Global Consultants in furtherance of the project implementation as per Government approval and in accordance with the Global Consultancy Agreement.
- v. Providing necessary infrastructural inputs to the Technical Advisory Team.
- vi. Assisting the Project Office in all infrastructural aspects in the implementation of the project.
- vii. Finalizing the specifications of civil works elevations, drawings, architectural layouts and for the entire process of procurement related to civil works.
- viii. Negotiations with suppliers/civil contractors/ construction supervisors.
- ix. Continuous monitoring of environmental aspects, licenses permissions for contractions with the relevant authorities and supervising commissioning of all equipments in close coordination with Director (Technical).
- x. Any other work as assigned from time to time.
