#### I. COMPANY PROFILE

Bharat Heavy Electricals Limited (BHEL)- a Maharatna Company, is the largest engineering enterprise of its kind in India. BHEL caters to the needs of core sectors like power, transmission, transportation (including railways), defence, telecommunications and various industries like petrochemicals, refineries, steel, cement, fertilizers etc. It has 17 manufacturing plants, 8 service centres and 4 power sector regional centres besides a large number of regional offices and project sites spread over India. ## II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Power) is a member of Board of the Directors and reports to Chairman and Managing Director. He/She is responsible for complete power setor business as well as new areas. The responsibilities include marketing & execution of large projects for providing end to end solutions.

#### 3. QUALIFICATION:

The applicant should be an Engineering Graduate with good academic record from a recognized university/Institution.

## 4. EXPERIENCE:

The applicant should have adequate experience at senior level(s) in a large organization of repute, out of which at least five years during the last ten years should be in areas catering to Power Sector Business preferably in Execution of large Power Projects.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

#### 3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
