With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of August, 2023 are highlighted:

- 1. MHI organized a conference on 'Annual Performance Review' of its 16 operational Central Public Sector Enterprises (CPSEs) at Vigyan Bhawan on 17.08.2023. The conference was chaired by Dr. Mahendra Nath Pandey, Hon'ble Minister of Heavy Industries. Minister of State for Heavy Industries & Power, Shri Krishan Pal Gurjar, CMDs & all Board of Directors of operating CPSEs including Independent Directors and senior officers of MHI participated in the Conference. This review is part of the Ministry's ongoing efforts to evaluate the efficacy of CPSEs towards fulfilling their core objectives, assessing their progress and achievements. During the meeting, all CMDs presented operational and financial performance of their CPSE for the Financial year 2022-23 and 1st Quarter (i.e. April to June) of 2023-24. CMDs also briefed about significant achievements and key initiatives for efficiency improvements, profitability enhancements, business expansion, modernisation and way forward for their CPSE.
- 2. Hon'ble Minister of Heavy Industries chaired the review meeting for PLI-Auto Scheme with all approved applicant companies on 29<sup>th</sup> August, 2023 at India Habitat Center wherein total 15 Original Equipment Manufacturer (OEM) applicants and 35 Component applicants participated. Applicants expressed satisfaction on the scheme progress.
- 3. I chaired the meeting of the Inter-Ministerial Apex Committee for the Capital Goods Scheme on 22<sup>nd</sup> August, 2023 to consider the new project proposals recommended by the Screening Committee under the Phase 2 of the Scheme for Enhancement of Competitiveness in the Indian Capital Goods Sector. New projects worth Rs.260 crores (approx.) have been identified for further progress in terms of scheme guidelines.
- 4. Demand Incentive of Rs.193.67 crores (approx.) was released to M/s. IFCI Ltd. for further disbursement to various OEMs under FAME-India Scheme Phase-II for e-2W, e-3W and e-4Ws.
- 5. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In August, 2023, a total of 202 GST Concession Certificates were issued.
- 6. "Har Ghar Tiranga" programme was celebrated successfully by MHI and its Central Public Sector Enterprises (CPSEs) and Autonomous Bodies during 13<sup>th</sup> 15<sup>th</sup> August, 2023 with great enthusiasm and fervour.

- 7. The Swachhta Pakhwada 2023 was observed successfully by MHI and its CPSEs and ABs from  $16^{th} 31^{st}$  August, 2023.
- 8. MHI alongwith its CPSEs and ABs actively participated in 'Meri Maati Mera Desh' programme during 9<sup>th</sup> 15<sup>th</sup> August, 2023. 'Panch Pran Pledge' was administered across all the establishments of these CPSEs and ABs during this programme.
- 9. BHEL has successfully manufactured India's first set of Selective Catalyst Reactors (SCR) for limiting NOx emissions for the 5x800 MW Yadadri Thermal Power Station in Telangana. Notably, it is a significant milestone under the 'Make in India' initiative of the Government of India as these catalysts were hitherto being imported.
