Dear Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated August 5, 2014 of Cabinet Secretary, the following significant activities in the Department of Heavy Industry (DHI) for the month of December, 2020 are highlighted:

- The Hon'ble Minister of State for Heavy Industries & Public Enterprises Shri Arjun Ram Meghwal visited NATRAX, Indore on 17<sup>th</sup> December, 2020 to review various facilities of NATRAX and its current status.
- 2. I chaired the first meeting of Inter- Ministerial Committee (IMC) for Capital Goods Sector (CG) on December 16, 2020. This has been constituted to coordinate efforts and actions for the expedited development of a globally competitive CG sector with the Ministries using Capital Goods. Suggestions, interventions and steps required for strengthening the sector to achieve the goal of achieving a USD 1 trillion manufacturing sector were invited. More than 30 senior level officers from various Ministries and experts from the concerned user CPSEs attended the meeting, useful suggestions were received.
- 3. On December 17, 2020, I chaired the inaugural session of the 5<sup>th</sup> Edition of the "CII Capital Goods Summit 2020-Atmanirbhar Bharat in Capital Goods" where new opportunities arising in demand creation, development of Technology and R&D, issues relating to cost competitiveness and export promotion were discussed. The Industry was apprised about the vision of the Government and various steps being undertaken in this regard.
- 4. The meeting of Project Steering Committee Department of Heavy Industry was held on 17<sup>th</sup> December to review the status of UNIDO-ACMA-DHI Partnership Programme Phase-II. The project aims at upgrading the skills and improving productivity of the MSMEs in the automobile sector.
- 5. Under FAME-India Scheme Phase-II, the supply orders for 240 Electric buses (150 e-buses in the city of Pune, 50 in Navi Mumbai and 40 in Mumbai) were issued by the respective City/State Transport Undertakings.

- 6. Letter of Awards were issued for 50 charging stations (10 in Vellore, 25 in Madurai, 10 in Salem and 5 in Gurugram) as sanctioned under FAME India Scheme Phase-II.
- 7. BHEL signed a Memorandum of Understanding (MoU) with M/s INTAMIN, Liechtenstein, on 9 December 2020 for the indigenous manufacture of Mumbai Metropolitan Region Development Authority (MMDA) Monorail trains.
- 8. The first in the series of online workshops on collaborative manufacturing 'BHEL Samvaad'- a step towards developing self-reliance in manufacturing, under the guidance of the Department of Heavy Industry (DHI) was held on 21 December 2020. The workshops are aimed at fostering better utilization of assets for development of technologies and products across Indian Industries including MSMEs, for increased cooperation in indigenous manufacturing.
- 9. BHEL received the following awards and recognition: Golden Peacock Environment Award-2020' in the Power Equipment Sector, the 'Clarivate South and South East Asia Innovation Award-2020' in 'Corporations Category' -the award put BHEL among top 28 innovators in South and South East Asia based on volume of patents, grant success rate, extent of globalization and influence of innovation.
- 10. The Annual Report and Financial statement of BHEL for the year ended 31 March 2020 has won the coveted prestigious 'ICAI Award for Excellence' in Financial Reporting for 2019-20.
- 11. In view of the Cabinet Secretariat's direction dated 12-01-2017 vide D.O letter No.1/50/1/2017-Cab, the status of ACC directions/ orders as per the prescribed format are given as under:
