Dear Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated August 5, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of November, 2021 are highlighted:

1. Pre-Bid Meeting for Advanced Chemistry Cell Battery Storage was held on Nov'12, 2021. The response to the pre-Bid meeting was encouraging and over 100 representatives from about 20 domestic/global manufacturers participated in the meeting.
2. Letters of Award were issued for 1,576 EV Charging Stations across 9 Expressways and 16 Highways, sanctioned under FAME India Scheme Phase-II. First tranche of incentive for deployment of 300 Electric buses for the city of Delhi and second tranche of incentive for deployment of 180 Electric buses for the city of Mumbai were also released under the Scheme.
3. Application Form for PLI Scheme for automobile and auto components, List of Advanced Automotive Technology Products and Notice Inviting Applications have been published on Nov 10, 2021. Window for Notice Inviting Applications is open for 60 days from Nov'11, 2021 to Jan'9, 2022.
4. For wider publicity of PLI for Automobile and Auto components, two Global Virtual Events were organized in November, 2021:
 - (i) Event organized on Nov'17, 2021 in association with Invest India for German Auto Association.
 - (ii) Event organized on Nov'26, 2021 in association with German Embassy and BMW Group.
5. Complying with the directives of Cabinet Secretariat for digitization of official records, the work of digitization of more than 15 lakh pages (accumulated since inception of the project) were completed in November 2021 for NAB (NATRIP)/HQ. This is a major work accomplished by NAB (NATRIP) organization in time bound manner.
6. Issue of GST Concession Certificate is one of the important services being provided by this Ministry under its Citizen's Charter. This Ministry has issued 1,844 GST

Concession Certificate in 9 months period from January to November 2021 surpassing the number of GST Concession Certificates issued manually from 2017 to 2020.

7. Hon'ble Prime Minister in the presence of Hon'ble Minister of Tribal Affairs, Government of India on Nov' 15, 2021 laid foundation stone via video conferencing for the Project "Eklavya Model Residential School" being executed by Engineering Projects (India) Ltd. at following locations:
 - (i) Araku Valley, Visakhapatnam, Andhra Pradesh.
 - (ii) Gadchiroli-Korchi, Amravati-Dharni, Palghar – Dahanu, Maharashtra Nos).
8. Hon'ble Minister of Heavy Industries on Nov'15 2021 inaugurated the renovated Corporate Office Building of Hindustan Salts Ltd (HSL) & Sambhar Salts Ltd (SSL) and REIL HOUSE - an infrastructure for Information Technology, Education, Training and Research & Development for Rajasthan Electronics & Instruments Ltd at Jaipur. He also virtually inaugurated 3 Solar Panels of capacity 400 KW, 350 KW and 1000 KW of SSL at Sambhar, Gudha and Nawa.
9. Hon'ble Minister of Heavy Industries on Nov'17 2021 inaugurated prototype Air Pollution Control Tower (APCT) indigenously designed and developed by BHEL and installed in Noida, Uttar Pradesh.
10. Hon'ble Minister of Heavy Industries on Nov'11 2021 reviewed power projects of NTPC being implemented by BHEL.
11. I participated in the inaugural session of the 6th edition of the CII Capital Goods Summit held on Nov'16, 2021 in Bengaluru wherein I addressed the gathering of the members of the industry elucidating the efforts made the Government towards building a Globally Competitive, Self-reliant and Sustainable Capital Goods Industry in the Country.
12. BHEL has entered into a License Agreement (LA) for Upgraded Super Rapid Gun Mount (the main gun on Indian warships) with M/s Leonardo S.p.A., Italy on Nov' 26, 2021 to meet the strategic needs of Indian Navy.
13. BHEL signed a cooperation agreement with Zorya Mashproekt, Ukraine on Nov'16, 2021 for local manufacture of Marine Gas Turbines and Reduction Gears to power upcoming fleets of Indian Navy.
14. Four major units of BHEL (Haridwar, Bhopal, Hyderabad & Trichy) have won accolades under the 'CII-EXIM Bank Award for Business Excellence 2021'. The company's Haridwar and Bhopal Units have got the 'Platinum recognition award' and Trichy and Hyderabad units have been awarded the 'Gold Plus recognition'. The Award is based on the internationally recognised European foundation of quality management (EFQM) excellence model.
