With reference to the D.O. letter No.502/1/2/2014-CA-V dated 5th August, 2014 of the Cabinet Secretary, the following significant activities in the Department of Heavy Industry (DHI) for the month of January, 2021 are highlighted:

- 1. I chaired a meeting on 18th January, 2021 to discuss the inclusion and promotion of the defense and aerospace products in the Production Linked Incentive Scheme. The Secretary, Department of Defence Production also participated in the meeting.
- 2. I chaired an inter-ministerial (virtual) meeting on 21st January, 2021 to discuss issues relating to Ethanol Blending with Secretary, MoPNG, the representatives from SIAM and ARAI also participated in the meeting.
- 3. The sixth inter ministerial meeting of the Review Committee for the issues relating to the implementation of the Capital Goods Scheme was chaired by me on 28th January, 2021. The subject matter in this meeting was facilitating the creation of an eco-system for research and development for manufacturing technology through the development of web based open manufacturing technology innovation platforms.
- 4. The significant activities during the month under the FAME-India Scheme Phase-II, are:
- i) The second tranche of the incentive was released for the deployment of 50 electric buses (in the city of Mumbai).
- The first tranche of the incentive for the deployment of an additional 90 electric buses was released.
- iii) The Letter of Award was issued for 10 EV Charging Stations (in the city of Erode).
- 5. The National Company Law Tribunal (NCLT), Kochi has on 29.1.2021 approved the resolution plan submitted by the Kerala Industrial Infrastructure Development Corporation (KINFRA) for Hindustan Newsprint Limited (HNL), a CPSE under the Department. The Resolution Professional (RP), HNL has informed that this resolution plan was earlier approved by the Committee of Creditors (CoC) of HNL and submitted to NCLT, Kochi by the Resolution Professional (RP), HNL. HNL, Kerala is a wholly owned subsidiary of Hindustan Paper Corporation (HPC), a CPSE under this Department that is facing liquidation proceedings since May 2019.
- 6. The Unit No. 3 of the Kakrapar Nuclear Power Plant (KAPP) has been synchronised with Nuclear Steam. BHEL supplied the Steam Turbine and Generator Package for the project-India's first of its kind, highest rated, 700 MWe Presurised Heavy Water Reactor.

- 7. BHEL has launched an initiative titled 'Connect-Collaborate-Create' on 25th January, 2021 to communicate with each employee of the company, discuss organizational issues and challenges, listen to them and unleash the power of synergy for developing a stronger BHEL.
- 8. The following awards and recognition were accorded to BHEL:
- (i) The 'ICAI National Award for Excellence in Financial Reporting' for FY 2019-20. The award was received by Director (Finance), BHEL from Shri Arjun Ram Meghwal, Hon'ble Union Minister of State for Parliamentary Affairs and Heavy Industries & Public Enterprises. Notably, BHEL has won this award after nearly four decades and was selected by an independent jury in the 'Infrastructure and Construction Sector' category.
- (ii) BHEL signed Non-Disclosure Agreements with:
 - (a) TALGO India Pvt. Ltd.on 14th January, 2021 for jointly addressing upcoming requirement of rolling stock for Indian Railways project for passenger train operations under Public-Private Partnership model.
 - (b) Siemens India on 12th January 2021 for Diesel to Electric Loco conversion project.
- 9. The BBJ company has been awarded the "Protshahan Puraskar" under "Corporate Offices Group" on 28th January, 2021 by the Town Official language Implementation Committee (PSUs) Kolkata for outstanding performance in the field of Official Language Implementation during the year 2019-20.
