# MONTHLY SUMMARY OFSIGNIFICANT ACTIVITIES FOR FEBRUARY, 2017

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of February, 2017 in the Department of Heavy Industry (DHI).

- Secretary(HI) attended a meeting held on 2<sup>nd</sup> February, 2017 at Cabinet Secretariat wherein Department of Public Enterprises made a presentation on 3<sup>rd</sup> Pay Revision Committee report for revision of pay for executives and non-unionized supervisors in CPSEs.

- 12. Industrial Advisor attended the Inter-Ministerial meeting held on 22<sup>nd</sup> February, 2017 at Indira Paryavaran Bhawan in connection with making preparation for participation of GOI in the upcoming Stockholm convention, Rotterdam Convention and Basel Convention.
- 13. A Presentation on promotion of Digital Payments/Cashless Transactions was made by NITI Aayog on 1<sup>st</sup> February, 2017 in Udyog Bhawan, New Delhi for DHI's officials.
- 14. A meeting was held on 9<sup>th</sup> February, 2017 with SIAM & ACMA to discuss the issues regarding make in India initiative.

- 16. BBJ has got the order for construction of "Keshrekha Bridge" over Muruli Khal in Midnapur District, West Bengal.
- 17. BHEL has achieved a provisional turnover of Rs.24,757 Cr. upto to February, 2017 as against Rs.21,464 Cr. For the corresponding period last year, an increase of over 15%.
- 18. BHEL has been selected as one of the Top 25 Best Companies to work for in India. CMD, BHEL received this prestigious recognition from Sh. Suresh Prabhu, Hon'ble Union of Railways in Mumbai. Significantly, BHEL is the only PSU to figure in the distinguished list compiled by an open, web based survey for all salaried employees in India, conducted by Business Today magazine in partnership with People Strong.

- 19. BHEL in association with Shraddha Cancer care trust constructed 30 bedded hospital "Ganga Prem Hospice' near Rishikesh for cancer patients. The Hospital provides Medical, "Social, Emotional and Spiritual support for individuals and loved ones as they face life threatening disease cancer.
- 20. BHEL, Trichy, has won the Greentech Environment Award in the engineering sector for the second successive year for outstanding contribution to environment management. BHEL Trichy has been selected for the award for planting over one million trees on 95% of its total area, creation of awareness on solid waste management among employees, township residents and students and teachers of campus schools, collecting rain water in disused quarries and using it for horticulture.
