### A) BRIEF INTRODUCTION OF HMT LIMITED:

HMT Limited is a Central Public Sector Undertaking under the Ministry of Heavy Industries and Public Enterprises of the Government of India. Started as Hindustan Machine Tools Limited (HMT) in the year 1953 for manufacture of Machine Tools, HMT expanded its product range over the years to include Watches, Tractors, Printing Machinery, Dairy Machinery, Metal & Plastic Forming Machines, Bearings etc., and set up manufacturing facilities for these products across the country, to emerge as an engineering conglomerate. Hindustan Machine Tools Limited was renamed as HMT Limited in 1978. HMT contributed significantly to the agricultural growth of the country through tractors manufactured to suit local conditions.

To meet the emerging needs of the Capital Goods Sector and in view of the enormous potential of the Machine Tool Sector for promoting "Make in India", and imparting skills to the youth to "Skill India", HMT, has decided to provide prime focus on its core business of Machine Tools and shelve its present operations of manufacture of Watches, Bearings and Tractors. ### A) BRIEF INTRODUCTION OF HMT LIMITED

HMT Limited is a Central Public Sector Undertaking under the Ministry of Heavy Industries and Public Enterprises of the Government of India. Started as Hindustan Machine Tools Limited (HMT) in the year 1953 for manufacture of Machine Tools, HMT expanded its product range over the years to include Watches, Tractors, Printing Machinery, Dairy Machinery, Metal & Plastic Forming Machines, Bearings etc., and set up manufacturing facilities for these products across the country, to emerge as an engineering conglomerate. Hindustan Machine Tools Limited was renamed as HMT Limited in 1978. HMT contributed significantly to the agricultural growth of the country through tractors manufactured to suit local conditions.

To meet the emerging needs of the Capital Goods Sector and in view of the enormous potential of the Machine Tool Sector for promoting "Make in India", and imparting skills to the youth to "Skill India", HMT, has decided to provide prime focus on its core business of Machine Tools and shelve its present operations of manufacture of Watches, Bearings and Tractors. In this direction, HMT has already received approval of the Government for closure of operations of HMT Tractor Division and most of the employees have been relieved on VRS and all employee related and other liabilities are being settled.

Hence, the Company now proposes to license / lease out its Tractor manufacturing facilities on "As is where is" basis to interested parties <u>preferably engaged in Capital Goods or Auto Sector</u> on Medium / Long term basis and invites "Expression of Interest" for the same. A brief note on HMT's Tractor business is as below:

### **HMT TRACTORS**

HMT started manufacturing of Agricultural Tractors in 25 HP category in the year 1971 at its Pinjore Plant in technical collaboration with M/s Motokov, Czechoslovakia under "Zetor" brand and in the year 1976, entered into another technical collaboration with M/s. Motokov for production of 58 hp tractors. HMT developed several models in the range 25 HP to 75 HP through its' own in-house R&D efforts. In 1986, HMT upgraded tractor engine through a technical collaboration with M/s AVL, Austria for better performance, particularly fuel consumption. The salient features of HMT Tractors are choice of hydraulic brakes or mechanical brakes, power steering, Cerametallic clutch in higher HP models, direct axle or split axle drive depending on end application, etc.

The tractor manufacturing activities were carried out at **Pinjore in Haryana with** additional Assembly facilities at Mohali in Punjab and Hyderabad in Andhra Pradesh. HMT has an installed capacity for manufacture and assembly of 8500 tractors per annum. Sales of HMT Tractors were channeled through Dealers / Distributors spread across the country.

HMT also has a Machine Tool manufacturing Unit operating from the same premises and some of the facilities are shared between the two Units. However, the factory area will be segregated with a clear demarcation for Licensing / Leasing purpose. An indicative sketch of the factory layout showing the proposed demarcation is as per **Annexure-I.** 



### B) BRIEF OVERVIEW OF PINJORE UNIT:

HMT established a factory for manufacture of Machine Tools during the year 1963 and a factory for manufacture of Tractors during 1971 at Pinjore, in a beautiful locale near the famed Pinjore Gardens and against the backdrop of Shivalik hill range. The factories and township spread over an area of around 840 acres are located adjacent to the National Highway in close proximity of the tri-cities of Chandigarh, Panchkula and Mohali. Facilities in the township include Residential Quarters, Schools, Hospital, Banks, Post Office, Petrol Bunk, Shops etc as also Temple, Gurudwara and other places of worship. There are over 1100 residential quarters in various sizes / types in the township of which currently around 500 houses are vacant.

The Applicant should submit a General Power of Attorney (GPA), authorizing the signatory of the Application to commit the Applicant to the response.

An Applicant can take 100% benefit of the technical capability and financial capability of a Parent Company for the purpose of evaluation. Any Company will be required to have at least 26% equity either directly or indirectly in the Applicant Company to be considered as its Parent Company. If an Applicant wishes to draw upon the technical and financial capability of its Parent Company, it will have to submit legally binding undertaking supported by a Board resolution at the time of the submission of the Tender Document (on qualification) from its Parent Company that all the equity investment obligations of the Applicant shall be deemed to be equity investment obligations of the Parent Company and in the event of any default the same shall be met by the Parent Company.


