1. The Department is in the process of preparing a National Mission for Electric Mobility Plan. In the meeting three Working Groups (WGs) have been constituted in the areas of Demand & Supply, R&D and Infrastructure. meet immediately and finalise the specific issues that can be incorporated in the National Electric Mobility Mission Plan 2020 (NEMMP 2020).
