#### MONTHLY SUMMARY OFSIGNIFICANT ACTIVITIES FOR January, 2017

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of January, 2017 in the Department of Heavy Industry (DHI).

- Hon'ble Union Minister for HI&PE, Sh. Anant Geete inaugurated BHEL's state-of-the-art manufacturing lines of 200 MW solar photovoltaic module and upgraded-105 MW solar photovoltaic cell, at BHEL plants in Bengaluru. With these lines, the annual manufacturing capacity of BHEL has been enhanced to 105 MW of solar cells and 226 MW of solar modules.
- 2. 2<sup>nd</sup> Meeting of Inter-Ministerial Group was held on 17<sup>th</sup> January, 2017 under the Chairmanship of Secretary (HI) to discuss the issues regarding payment of outstanding fiscal incentives under the MoU between Government of Tamil Nadu and M/s Nissan Motors Company Limited.
- 3. Fifth (5<sup>th</sup>) Apex Committee Meeting in connection with implementation of the Scheme on "Enhancement of Competitiveness in the Indian Capital Goods Sector" was held on 17<sup>th</sup> January, 2017 under the Chairmanship of Secretary (HI) for considering:
  - (i) Funding the projects under the Schemes of the Ministry of Human Resource Development in the field of Capital Goods, and
  - (ii) Proposals under Technology Acquisition Fund Programme (TAFP) Component of the Capital Goods Scheme.
- 2nd Meeting of the Development Council for the Earthmoving, Construction and Mining Machinery Industry was held on 25th January, 2017 at Bangalore under the Chairmanship of Secretary (HI) for considering various issues concerning the Sector.
- SIAT-2017, an International Conference on Automobile Technology, was held in Pune from 18-21 January, 2017 by ARAI and it witnessed the participation of more than 1400 delegates from across the world.
- Stakeholders consultation on extension of FAME-India Scheme was held on 9<sup>th</sup> January, 2017.
- A meeting was held on 5<sup>th</sup> January, 2017 with ARAI under the Chairmanship of Joint Secretary (Auto) to review ongoing projects under Cess Fund.
- 8. BHEL has achieved a provisional turnover of Rs.21,589 Cr. up to January, 2017 as against Rs.18,700 Cr. for the corresponding period last year, an increase of over 15%.

- 9. BHEL Day 2017 was celebrated with great fervour in New Delhi. Sh. Anant Geete, Hon'ble Union Minister for HI&PE graced the occasion as the Chief Guest and Sh. Babul Supriyo, Hon'ble Minister of State for HI&PE was the Guest of Honour. CMD/ BHEL, Directors on the Board of BHEL, Secretary (HI) and other senior officials of the DHI were present on the occasion.
- 10. 12 employees of BHEL have been selected for 7th nos. Prime Minister's Shram Awards (Shram Bhushan 1, Shram Vir 5 & Shram Shree 6) for the year 2015, in recognition of their distinguished performances.
- 11. Persistent efforts by DHI & BHEL with MoP and CEA resulted in issuing an advisory (validity 3 years) for sourcing of supercritical units from indigenous manufacturers without the condition of Deed of Joint Undertaking (DJU) from foreign collaborators; accordingly, BHEL will now be able to qualify on its own for participation in supercritical tenders on completing the stipulated qualifying conditions.
- 12. Sh. Atul Sobti, CMD was honoured as one of the country's eminent engineering personalities by the Institution of Engineers—the largest multidisciplinary body of engineers in India, for his notable achievements & contribution to the engineering profession.
- 13. Dr. Mahendra Nath Pandey, Hon'ble Minister of State for HRD conferred Sh. Atul Sobti, CMD, the Industry Honour for Visionary Leadership in Heavy Engineering at the 6<sup>th</sup> EPC World Awards in New Delhi for his exceptional contribution in the infrastructure and engineering sector.
  - 14. BHEL has won the prestigious Golden Peacock HR Excellence Award for 2016 for exemplary contribution to the HR function. The award was received by Sh. Atul Sobti, CMD & Sh. D. Bandyopadhyay, Director (HR) from Sri Ravi Shankar.
  - 15. BBJ has contributed an amount of Rs.1.0 Cr. (Rupees One Crore) to Swachh Bharat Kosh for construction of toilets in the school as a part of Swachh Vidyalaya Campaign.
- 16. A meeting was held on 16<sup>th</sup> January, 2017 alongwith DIPP wherein a presentation was made by Shri. Vikash Sehgal, Advisor-Invest India was made which is on 'Build vs Manufacture- A Choice for Make in India'.
