Department of Heavy Industry Monthly Summary of Significant Activities for January, 2018

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of January, 2018 in the Department of Heavy Industry (DHI).

- A conference on electric mobility was organised by the Department on 10.01.2018 which
 was presided over by Shri Anant Geete, Hon'ble Minister for Heavy Industries & Public
 Enterprises (HI&PE). Various Auto sector Original Equipment Manufacturers (OEMs) and
 manufacturers of components and industry associations shared their views on the way
 forward in electric mobility.
- 2. Thirteen Test Tracks were inaugurated by Shri Babul Supriyo, Hon'ble Minister of State (HI&PE) on 28th January, 2018 at National Automotive Test Tracks (NATRAX), Indore, a Greenfield center of National Automotive Testing and R&D Infrastructure Project (NATRIP). This has put NATRAX on the world map, being Asia's largest automobile proving ground and one of the largest in the world. The facility is compliant with various National and International standards and an asset for promoting 'Make in India'.
- 3. HEC, Ranchi dispatched Reactor Pressure Vessel, made to BARC standards, to BHEL Trichy, for use by Indian Navy.
- 4. The anti-suit injunction case filed by the Tamil Nadu government in the context of International Arbitration by Nissan Motors Ltd. came up for hearing on 22nd January 2018 before the Madras High Court. The government of Tamil Nadu filed counter reply in the Hon'ble High court on 12th February, 2018. The matter has since been posted now for final arguments on 19th February, 2018.
- 5. A German Delegation led by Mr. Stephen Schnorr, Director General and Head of Department for Digital and Innovation Policy visiting the Department of Consumer affairs also met with Secretary, DHI on 16.01.2018 to discuss and enhance the bilateral cooperation between the two countries in the fields of Heavy Engineering, Machinery Safety, Homologation process in Automobiles and Electric Mobility. Creation of quality infrastructure, development of safety standards, standards for Electric Vehicle Charging were discussed with a view to enhance Indo-German cooperation in these areas.
- 6. To give a push to disposal of land and immovable assets of CPSEs of DHI under closure, Secretary, DHI held a meeting in the nature of a roadshow on 9th January, 2018 with various Ministries / Departments / attached offices / subordinate offices including offices of various armed forces of GoI to apprise them about the availability of land etc. under the tender issued by the NBCC (India) Ltd. which is the Land Management Agency. The bids close on 7th February 2018.
- 7. As per directions of Core Group on Disinvestment on disinvestment of Scooter India Limited (SIL), Lucknow, consultations with specified Ministries and the Govt. of UP were held and recommendations were finalized and sent to DIPAM regarding the use of non-core land of SIL and its impact on valuation of the company. A meeting with Govt. of UP was held and a way forward was suggested on the land issues in the disinvestment case of Bharat Pumps and Compressor Ltd.

- 8. A review of 77 completed/executed projects and 27 ongoing projects of BHEL was undertaken with a view to minimising time and cost over-runs.
- 9. A meeting of Development Council for Textile Machinery was held on 17th January, 2018 with the representatives of Industry / Central Ministries and Departments to discuss the progress and future plan of Textile Machinery Industry. Three projects on Textile Machinery sanctioned under Capital Goods Scheme were reviewed in the meeting.
- Andrew Yule Co. Ltd. and Bridge & Roof Co. Ltd have paid dividends of Rs. 4.36 Crore and Rs. 4.87 Crore respectively for the year 2016-17.
