MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR JULY, 2016

- 1. The Department of Heavy Industry (DHI) has filed the Status Report regarding Compliance of Orders dated 18th July 2016 & 20th July 2016 of National Green Tribunal (NGT) in the matter of Vardhman Kaushik & Ors vs UOI & Ors on 28th July 2016. Through this report, the Department has also expressed the concern of the Government on ban of diesel vehicles older than 10 years as per the said Orders of the Hon'ble NGT. The Department is also preparing to file an Appeal in Hon'ble Supreme Court against the aforementioned orders of Hon'ble NGT.
- CCEA in the meeting held on 27th July 2016 approved the Revised Cost Estimates-II of NATRIP.
- 3. INNOPROM, one of the largest Annual Industrial Exhibition Fair of Russia was held in Moscow from 9th to 13th. July, 2016. India was the partner country in the event. India's participation at INNOPROM was led by Hon'ble Minister of State, Commerce & Industry Smt. Nirmala Sitaraman. The exhibition was attended by Senior Officers of DHI and also from some of important CPSEs of DHI like Heavy Engineering Corporation Ltd (HEC) and Andrew Yule & Company Ltd. (AYCL).
- 4. CEO, NITI Aayog held a meeting with Secretary, HI (SHI) and Chief Secretary, Jharkhand on the issue of transfer and monetisation of HEC land to the Government of Jharkhand. Additional Secretary, DHI and Joint Secretary, DHI had a further meeting with Chief Secretary, Jharkhand in this regard. Secretary, HI and other senior officials attended meetings in PMO on 13th July and 26th July, 2016 chaired by the Principal Secretary to the PM on the future of HEC. Consequent upon directions of PMO, an order was issued constituting a Committee of Experts under Dr. V.K. Saraswat, Member, NITI Aayog to examine the modernization plan of HEC.
- A meeting of 'Auto Cess Committee' chaired by SHI was held on 19th July 2016 to review the ongoing projects and some other new projects to be financed through Auto Cess Fund.
- 6. A meeting of 'Project Implementation Sanctioning Committee [PISC} under FAME-India Scheme of the Department was held on 20th July 2016 under the chairmanship of Secretary, Heavy Industry to review the progress of the Scheme and for providing further directions and guidance to promote its objectives.
- 7. A meeting was held with Additional Chief Secretary (Industries), Government of Karnataka by Joint Secretary, DHI on 12.07.2016 at Bangalore to discuss the

progress/steps for release of grant for Machine Tool Park at Tumkur and sale of freehold land of Tungabhadra Steel Products Ltd at Hospet, Bellary to Government of Karnataka. Meeting ended on a positive note with Additional Chief Secretary (Industries), Government of Karnataka assuring to take necessary steps for expediting the project of Machine Tool Park & exploring the possibilities of procuring the TSPL land.
