## Monthly Summary for the month of June, 2015

The report of Department of Heavy Industry for the month of June, 2015 is as follows:

An initiative to cover non-plan payments of Government Departments under the Public Financial Management System(PFMS), the online management and payment portal, currently being used only for disbursement of plan funds, has been approved by Finance Minister. Department of Heavy Industry is the first to volunteer and fully implement the PFMS for non-plan payments as well.

- 2. PMO has desired to ascertain the views of automobile industry regarding the suggestion for advancing introduction of BS VI fuels in the country. In this connection a meeting of major automobile manufacturers and technology providers was held on 3<sup>rd</sup> June, 2015. Principal Secretary to Prime Minister has been apprised of the outcome of the meeting.
- 3. A Joint Programme on Cooperation (JPC) in Electric Mobility has been signed between the Department of Heavy Industry, Government of India and the Ministry of Economic Affairs of the Kingdom of the Netherlands during the visit of Hon'ble Prime Minister of Netherlands to India on 5<sup>th</sup> June, 2015. This JPC was signed under the Joint Declaration of Intent between the two countries on 19<sup>th</sup> April, 2012 for overall exchange in the automobile sector.
- 4. A rally of Electric and Hybrid Vehicles from India Gate to Terminal 3 of Delhi Airport was organised on the occasion of World Environment Day on 5<sup>th</sup> June, 2015 by the Department to promote the acceptance of Electric and Hybrid Vehicles under National Mission on Electric Mobility. The rally was flagged off jointly by Hon'ble Minister for Heavy Industries and Public Enterprises and Hon'ble Minister of Environment, Forest and Climate Change.
- 5. Bharat Heavy electricals Limited (BHEL) has successfully commissioned the largest thermal power plant with the capacity of 500MW consisting of four units of 125 MW each at Kosti in Sudan. The complete power project has been designed, manufactured, supplied and installed including associated civil works by the company.
- 6. Engineering Projects India Limited (EPI) has been executing a high security contract for border fencing in Oman. This work is also being monitored on our side by the office of the National Security Adviser. Due to their performance on site, the Company has been awarded the contract for the second phase of the project by the Royal Army of Oman. This contract valued at USD 470 million, is the largest ever secured by the Company, and represents a significant accomplishment by EPIL.
