Dear Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of June, 2022 are highlighted:

1. As part of the ongoing 'Azadi Ka Amrit Mahotsav' (AKAM) celebrations, the 8<sup>th</sup> International Yoga Day was celebrated by MHI on 21<sup>st</sup> June 2022 at Puri, Odisha. On this occasion, MHI organized mass yoga demonstration based on 'Common Yoga Protocol' under the theme of 'Yoga for Humanity'. Approximately 2000 participants including renowned local celebrities participated in the event.
2. Hon'ble Minister of Heavy Industries inaugurated the new production line at Toyota Kirloskar Auto Parts (TKAP) and laid the foundation stone for expansion of Toyota Technical Training Institute (TTTI), on 26<sup>th</sup> June, 2022 in Bengaluru. He chaired the 'Convocation Ceremony' at TTTI. The expansion of TTTI will increase the residential capacity from 600 to 1200 students per annum by August, 2023.
3. On 27<sup>th</sup> June, 2022, MHI signed an MoU with Ministry of Skill Development and Entrepreneurship (MSDE). The MoU is focused on facilitating strategic partnership between MHI and MSDE for imparting skilling of level 6 and above in several engineering trades through Qualification Packs developed under Scheme for 'Enhancement of Competitiveness in the Capital Goods Sector Phase-II'.
4. All 18 Performance Bank Guarantees (PBGs) have since been verified from respective banks in June 2022 under champion OEM scheme of PLI auto. Also, out of 67 PBGs, 40 PBGs have been verified in June 2022 under the Component Champion scheme of PLI Auto and balance PBGs are under different stages of verification.

5. Under FAME-II Scheme:

- i. 1<sup>st</sup> tranche of grant amounting to Rs.2.85 crore was released for deployment of 40 Electric buses in Chandigarh.
  - ii. Implementation Agreement for Technical Cooperation Project on climate-friendly e-mobility titled, "Promoting the transformation to sustainable and climate-friendly e-mobility" was signed with GIZ, Germany on 22<sup>nd</sup> June 2022 for promotion of climate-friendly electric mobility in India.
6. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In June 2022, a total of 229 GST Concession Certificates have been issued.
7. HMT Bearings Ltd. and HMT Chinar Watches Ltd., (both subsidiaries of HMT Ltd. under closure as per decision of Cabinet) have been deleted from the list of the Registrar of Companies (RoC).
8. BHEL's Bhopal Unit won the prestigious 'Economic Times DataCon Award 2022', in the category of 'Automated Data Management'. The award recognizes path-breaking initiatives undertaken by Indian enterprises towards becoming data-centric.
