MONTHLY SUMMARY OFSIGNIFICANT ACTIVITIES FOR MARCH, 2017

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of March, 2017 in the Department of Heavy Industry (DHI).

- Hon'ble Minister Shri Anant G. Geete (HI&PE) laid the foundation stone of Common Engineering Facility Centre (CEFC) for Textile Machinery and Light Engineering on 26th March, 2017. The CEFC is coming up in Bardoli, Gujrat by Science Engineering and Technology Upliftment (SETU) foundation under the Capital Goods Scheme of Department of Heavy Industry.
- The first meeting of the Inter-Ministerial Standing Committee (IMSC) for Development of Capital Goods Industry was held on 8th March, 2017 under the Chairmanship of Secretary (HI) to consider the issues related to Public Procurement Policy as raised in the Development Council for Machine Tools Industry.
- 3. A presentation was made by Secretary (HI) on "National Mission on Electric Mobility-Current Status and Way Forward" before the Hon'ble Finance Minister at North Block on 9th March, 2017.
- A meeting of Sanctioning Committee under the Chairmanship of Secretary (HI) for extending financial support to projects/proposals received under Auto Cess Fund was held on 9th March, 2017.
- 5. The Union Cabinet has given approval for Monetization of land not currently in use by Heavy Engineering Corporation Limited Ranchi, (HEC) through transfer of Rs.675.43 acres of HEC land to the Jharkhand Government. It would help in raising Rs.742.98 Crore to HEC and the money would be utilized for liquidation of employee related statutory dues viz Gratuity, PF Leave encashment and other retirement benefits to the retire employees. The Money will also help HEC to liquidate its Government dues, bankers dues and other immediate liabilities.
- 6. The Union Cabinet has also given approval for the proposals of (i) Transfer of HMT Watches Limited land at Bangalore and Tumkur measuring 208.35 acres, to India Space Research Organization (ISRO) on payment of Rs.1194.21 crore and applicable taxes and duties. (ii) Transfer of Bangalore (Global Warehouse) land of HMT Limited measuring one acre to Gas Authority of India Limited (GAIL) on payment of Rs.34.30 crore and applicable taxes and duties.
- Secretary (HI) have attended a meeting held on 3rd March, 2017 on 2nd IMG meetings for selection of Advisor for Bridge & Roofs Company (India) Limited (B&R) and Bharat Pumps & Compressors Limited (BPCL).
- 6th meeting of Project Implementation Sanctioning Committee (PISC) for funding under FAME India Scheme was held under the Chairmanship of Secretary (HI) on 23rd March, 2017.

- Joint Secretary of this Department has attended a meeting held on 8th March, 2017 of IMG for selection of Adviser for the Strategic Disinvestment of Engineering Projects (India) Limited (EPI) through merger with similar CPSEs.
- 10. Secretary (HI) have attended a meeting held on 30th March, 2017 of CoS meeting on proposal of Fixation of Government tenders at national level and also discuss on draft Guidelines for bringing more transparency and certainty in procurement of works.
- 11. A meeting of Technical Committee of Project titled "Source Apportionment of PM 2.5 & PM 10 of Delhi NCR for identification of major sources was held on 1st March. 2017.
- 12. Director of this Department has attended the 171st Session of World Forum for Harmonization of Vehicles Regulations [WP-29] at Geneva, Switzerland from 14-17 March, 2017.
- 13. The Department of Heavy Industry participated in the 6th edition of International Engineering Sourcing Show, 2017 (IESS, 2017), which was organized by EEPC India in Chennai during 16th to 18th March, 2017.
- Department of Heavy Industry in association with CII/ FICCI has conducted awareness workshops on Industry 4.0 in Coimbatore (20.03.2017), Bangalore (23.03.2017), Ahmadabad (28.03.2017) and Gurugram (29.03.2017).
- 15. The Department's Scheme titled "Excise Duty Concession for PwD (Orthopaedic) for purchase of vehicle" has been on-board in DBT Bharat Portal of Government of India on 30th March, 2017.
- 16. The Phase-I of FAME India Scheme has been extended further for a period of 6 months beyond 31st March, 2017 till 30th September, 2017, with modification to the extent of exclusion of benefits available for Mild Hybrid Technology under the scheme.
- 17. The Hon'ble Supreme Court has issued order dated 29th March, 2017 banning sale of vehicle, which are not BS IV compliant, with effect from 1st April, 2017.
- 18. During the 12th five year plan, BHEL has surpassed its target by 9% and achieved capacity additional of 45274 MW which is 78% more than its achievement during the 11th Plan.
- 19. BHEL has signed a contract with M/s India Railways for setting up 2 MW Roof-top Solar PV Power plant.
- 20. BHEL has participated in National Workshop on Water & Waste Water Sustainable Management organized by CSIR- NEERI on 27th & 28th March, 2017 at Chennai. BHEL presented the highlights of MoU-CSIR/BHEL and BHEL capabilities in Water Management.
- 21. BHEL has commenced commercial operation of first 800MW unit, super critical thermal plant. BHEL foray as a developer into the field of Power Corporation Limited (KPCL) and BHEL is the main equity partner of RPCL of this power plant. The Milestone was achieved for the first unit of 2×800MW Yeramarus Thermal Power Station of Raichur Power Corporation Limited (RPCL) in Raichur district of Karnataka.
