With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of May, 2023 are highlighted:

- 1. Hon'ble Minister of Heavy Industries, Dr. Mahendra Nath Pandey visited Naval Dockyard Mumbai on 29<sup>th</sup> May 2023, and appreciated Bharat Heavy Electricals Ltd. (BHEL)'s contributions to 'Aatma Nirbharta' under 'Make in India' through Super Rapid Gun Mount and other equipment and systems being indigenously manufactured and supplied by BHEL.
- 2. Hon'ble Minister of State (MoS) of Power & Heavy Industries, Shri Krishan Pal Gurjar inaugurated the Extension Centre of Common Engineering Facility Centre (CEFC), WRI Trichy at BHEL Haridwar on 23<sup>rd</sup> May, 2023. Hon'ble MoS Commended Team BHEL's technology, engineering & manufacturing capabilities, and appreciated BHEL's role in contributing to the Hon'ble Prime Minister's vision of an Aatmanirbhar Bharat.
- 3. I presided over a webinar organized by this Ministry on 'Public Procurement through Government-e-Marketplace (GeM)' on 18<sup>th</sup> May 2023, as a part of peer learning process to accomplish the vision of the Hon'ble Prime Minister for establishing an inclusive, efficient, and transparent technology driven ecosystem to facilitate the public procurement activities of Ministries, Attached Offices, Autonomous Bodies (ABs) and Central Public Sector Enterprises (CPSEs) in a fair and competitive manner. The webinar was well received and attended by more than 200 officials of MHI, its CPSEs and ABs from various locations all over country.
- 4. 8<sup>th</sup> Meeting of Project Implementation and Sanctioning Committee (PISC) was held on 19<sup>th</sup> May, 2023. Stakeholder consultations were held with OEMs of EVs under the FAME II scheme. Noting that the financial targets in respect of e-two wheelers and e-buses were achieved, the PISC enhanced the budget of e-2Wheelers under the scheme from Rs.2000 crores to Rs.3500 crores and the budget of e-buses from Rs.3545 crores to Rs.4307 crores. The aggregation of e-buses would be done by CESL. An enhanced portal for FAME II scheme was launched making it easier for OEMS to upload claims and for MHI to process the same.

- 6. I chaired monthly review meetings with beneficiaries on 17<sup>th</sup> May, 2023 and 22<sup>nd</sup> May, 2023 to review the progress of the Production Linked Incentive Advanced Chemistry Cell (PLI ACC).
- 7. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In May 2023, a total of 565 GST Concession Certificates have been issued.
