Dear Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated August 5, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of September, 2021 are highlighted:

- 1. Hon'ble Minister for Heavy Industries inaugurated MHI supported Samarth Udyog Center 'Smart Manufacturing Demonstration and Development Cell' on 6<sup>th</sup> Sept., 2021 at CMTI Bengaluru.
- 2. Handing Over Ceremony of Twin Screw Mixer and Extruder (TSME) developed by CMTI, Bengaluru for HEMRL, Pune was conducted on 20<sup>th</sup> September, 2021 in the kind presence of Hon'ble Minister for Heavy Industries, through virtual mode.
- 3. Under FAME India phase II scheme 2<sup>nd</sup> tranche of instalment of grant of Rs.13.5 crores was released to Ahmedabad Janmarg Ltd. for deployment of 150 Electric Buses in the city of Ahmedabad. 2<sup>nd</sup> tranche of installment of grant amounting to Rs 4.5 crores was also released to Delhi Metro Rail Corporation (DMRC) for deployment of 25 Electric Buses in the city of Delhi.
- 4. The Union Cabinet approved the Production Linked Incentive (PLI) Scheme for Automobile & Auto components on 15<sup>th</sup> September 2021. The Scheme and the Guidelines have been notified on 23<sup>rd</sup> September 2021 in the Gazette of India.
- 5. Issue of GST Concession Certificate to Orthopedically Disabled Persons is one of the important services provided by this Ministry under its Citizen's Charter. As a step towards Digital India, an online portal for issuing Aadhar Authenticated GST concession certificate was launched in November, 2020. The development of online portal has improved the quality of service rendered by this Ministry. This IT enabled initiative has helped streamline the process and facilitated issue of 1,511 GST Concession Certificates during the period from January, 2021 to September, 2021.
- 6. In compliance of directives issued by Cabinet Secretariat for digitization of records, NAB (NATRIP) has digitized 5.60 Lakh pages in September, 2021. This is a major step towards paperless working.
- 7. भारी उद्योग मंत्रालय में 14-28 सितंबर, 2021 तक हिंदी पखवाडा मनाया गया। इस दौरान मंत्रालय में नौ प्रतियोगिताएं आयोजित हुई: निबंध (राजपित्रत और अराजपित्रत किर्मियों के लिए अलग-अलग), अनुवाद, आशुभाषण, टिप्पण एवं आलेखन, हिन्दी व्याकरण और राजभाषा ज्ञान, हिन्दी टंकण, हिंदी श्रुतलेखन/शब्द ज्ञान प्रतियोगिता और वर्ष भर के दौरान मूल रूप से हिन्दी में अधिकाधिक कार्य संबंधी प्रतियोगिता। हिंदी की ओर ध्यानाकर्षण के लिए, राजभाषा सचिव के अनुरोध के अनुसार, पहली बार, मंत्रालय में 10 स्टैंडी लगाए गए जिनपर दस महापुरुषों की सूक्तियां उद्धृत थीं। पखवाड़े के दौरान स्मृति-आधारित अनुवाद पैकेज कंठस्थ पर कार्यशाला का आयोजन भी किया गया।
- 8. Hon'ble Minister for Heavy Industries inaugurated a modern, state-of-the-art Data Centre at BHEL's Electronics Division, Bengaluru. as a part of BHEL's Digital Transformation initiatives. This Data Centre at EDN encompasses the data centres of all the three Bengaluru-based units of BHEL, namely Solar Business Division (SBD), Industrial Systems Group (ISG), as well as Electronics Division (EDN). The facilities at these three units have been brought together and co-located in one place leading to optimised IT infrastructure, better data security and reduced operating cost.

- 9. I along with Addl. Secretary (Ministry of Power), CMD, BHEL, Director (HR & Power), BHEL and Director (Projects), NTPC visited sites of Thermal Power Projects at North Karanpura and Patratu on 12<sup>th</sup> September 2021 to review the progress.
- 10. 'Utkrishthta Utsav' was celebrated by BHEL, on 17<sup>th</sup> September, 2021 at its HERP Unit Varanasi, where 'Excel Awards' instituted by the Company were conferred on meritorious employees by the Hon'ble Minister for Heavy Industries. All the manufacturing units, divisions and offices of the company were connected live to the event through Video Conferencing.
- 11. As part of Government of India's initiative towards enhanced transparency and ease of doing business, BHEL has been spearheading procurement of Goods and Services through the 'Government e-marketplace' (GeM) portal. Further, the company is not only procuring goods and services through GeM, but is also registered as a 'Seller' for various products on the platform and is receiving orders from the same. Significantly, the company's procurement through GeM has crossed Rs 1,500 Crore in the first six months of the current fiscal, as against Rs.389 Crore in the entire 2020-21. The company was ranked number 1 among the PSUs for procurement from this portal during the first quarter of current year.
- 12. BHEL signed a Memorandum of Understanding with M/s. SIEMENS Mobility-Germany and M/s SIEMENS Ltd-India to jointly address the opportunities in upcoming light rail rolling stock segment (Metro Lite) in India.
- 13. Under CSR BHEL organized a camp at Damoh, Madhya Pradesh to distribute Aids & Assistive Devices to Persons with Disabilities (Divyangjan) in association with Artificial Limbs Manufacturing Corporation of India (ALIMCO). Total 90 Divyangjan were benefitted under this CSR initiative. The event was graced by Hon'ble MoS Govt. of India, Shri Prahlad Singh Patel, and Revenue Minister and Incharge, Damoh Shri Govind Singh Rajput.
- 14. Mining operation started at Manal Mines of Rajban Unit of Cement Corporation of India Ltd. successfully after extension of mining lease by Director of Industries, Government of Himachal Pradesh.
