

- i. Cabinet approval for return of land to Uttarakhand Government: Cabinet approved on 5th November 2015 the proposal for return of 803 acres of land situated at Hempur, Uttarakhand in the possession of NEPA Limited, Nepanagar to Government of Uttarakhand
- ii. Show Cause Notice by ARAI to M/s Volkswagen India: Following consideration of the Report submitted by Automotive Research Association of India (ARAI), Pune on the On Road Testing for Emission of Volkswagen vehicles, ARAI issued a Show Cause Notice to M/s. Volkswagen India.
- iii. FAME India scheme for Electric and Hybrid Vehicles: As part of the FAME India (Faster Adoption and Manufacturing of Electric Vehicles in India) scheme for Electric and Hybrid Vehicles and in the perspective of the forthcoming COP 21 Conference, DHI launched FAME Eco Drive in 3 cities (Delhi, Jaipur and Chandigarh) on 26th & 30th November and 7th December 2015, respectively. This event showcased a display of hybrid and electric vehicles in all the segments and organised a road rally through major streets to create awareness amongst the public/consumers about this clean and green mode of transportation. The event at Delhi on 26th November was graced by the Hon'ble Union Minister for HI&PE Shri Anant Geete and Hon'ble Minister of State for HI&PE Shri G. M. Siddeshwara.
- iv. MoU signed between DHI and Tools and Gauge Manufacturers Association (TAGMA) of India: An MoU was signed between DHI and Tools and Gauge Manufacturers Association (TAGMA) of India on 17th November for setting up of Common Engineering Facility Centre of Tools and Gauge at Chakan, Pune under the "Scheme for Enhancement of Competitiveness of Capital Goods Sector".
- Inter-ministerial meeting on Capital Goods Policy: An inter-ministerial meeting chaired by Secretary, HI was held on 19th November 2015 in DHI to consult different Ministries on the draft Capital Goods Policy.
- vi. MoU signed between Czech Republic and India for co-operation in Heavy Engineering: A Protocol was signed with the Deputy Minister, Ministry of Czech Industry and Trade, Czech Republic, Mr. Jiri Koliba on 24th November, 2015 to

promote bilateral co-operation between India and Czech Republic in the field of Heavy Engineering especially in construction and modernization of the existing facilities in India by the Czech companies including modernization of three plants of Heavy Engineering Corporation (HEC), a CPSE under DHI at Ranchi.

- vii. 3rd Meeting of the Indo Czech Joint Working Group on "Heavy Engineering": The 3rd Meeting of the Indo Czech Joint Working Group on "Heavy Engineering" chaired by Joint Secretary (HE&MT), DHI and Deputy Minister, Ministry of Czech Industry and Trade, Czech Republic was held on 24th November 2015 on the sidelines of the India Engineering Sourcing Show (LESS) at, Mumbai.
- viii. Workshop on High Technology Manufacturing: A workshop on "India's Collaborations with Advanced Markets for corporation in areas of High Technology Manufacturing" was held at IESS, Mumbai on 24th November 2015.

Meeting of the Development Council for Heavy Electrical & Allied Industries: The first meeting of the Development Council for Heavy Electrical & Allied Industries was held on 18th November 2015 in which short and medium term action points for the implementation of The Indian Electrical Equipment Industry Mission Plan 2012-22 were agreed upon.
