MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR NOVEMBER, 2016

1. On 30th November 2016, Union Cabinet has approved the closure of Kota unit of the Instrumentation Ltd and in principle transfer of Palakkad unit of Instrumentation Ltd to the Government of Kerala. This is a continuation of our efforts to rationalize the working of CPSEs under DHI.
2. Minister of State for HI&PE Shri Babul Supriyo chaired a meeting with IIT, Kharagpur and Industry in West Bengal on 30th November 2016 for developing a Centre of Excellence at IIT, Kharagpur under the Capital Goods scheme. The meeting with IIT Kharagpur is aimed at a more spatial distribution of projects under the scheme.
3. The second meeting of the Development Council for Textile Machinery Industry was held on 21st November 2016 at Coimbatore, under chairmanship of Secretary(HI) . The meeting was held in Coimbatore, a Textile Hub, to understand first hand issues facing the textile machinery industry.
4. An MoU has been signed between the Department of Heavy Industry and Scientific and Industrial Testing Research Centre (SITRC), Coimbatore on setting up of a Centre of Excellence (CoE) for development of Smart Submersible Pump for industrial use under the scheme for Enhancement of Competitiveness in the Indian Capital Goods Sector. The development of these prompts, which have been identified with a potential of having export capabilities by the M/o Commerce, is an effort at greater Inter-Ministerial synergy.
5. Secretary(HI) also carried out a review of the Centre of Excellence on Welding set up at PSG College of Engineering, Coimbatore under the Capital Goods Scheme and was impressed by the tremendous work being done across academic institutions harnessing Government-Industry-Academia partnership.
