With reference to D.O. letter No.502/1/2/2014-CA-V dated 5th August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of September, 2022 are highlighted:

- 1. Hon'ble Union Minister of Heavy Industries, Dr. Mahendra Nath Pandey inaugurated 'School of Welding' set up at BHEL, Varanasi on 17<sup>th</sup> September 2022. The facility, established under the 'Enhancement of Competitiveness in the Indian Capital Goods Sector, Phase-II' scheme of the Ministry of Heavy Industries, will provide skill training in various welding technologies to approximately 1,000 welders per annum and help in enhancing the employability of the youth in and around Varanasi to meet the requirements of industries.
- 2. I chaired a meeting regarding paperless and faceless disbursement for PLI (Auto) on 7<sup>th</sup> September 2022. MHI has introduced 'Application Programming Interface (API)' based Automated Data Transfer for capturing critical data related to Domestic Value Addition (DVA) from the Enterprise Resource Planning (ERP) system of beneficiaries' companies of PLI Auto and FAME II scheme along with traceability of product based on digital footprints. The API enables a smooth transfer of a set of predefined data from the beneficiaries existing ERP system to the Ministry's Portal in a safe environment and seamless manner. Keeping with the principle of Atmanirbhar Bharat, the product wise final DVA is automatically calculated and pushed to the Ministry's portal through API, without encroaching on the Non-Disclosure Agreements of the beneficiary companies.
- 3. Stakeholder Consultation meetings for suggestion and feedback for Quarterly Review Report (QRR) & Automatic Data Transfer through PLI Auto portal was held on 30.09.2022.
- 4. Under FAME-II, grants amounting Rs. 38.42 crores were released to City/State Transport undertakings as under:
  - i. 2<sup>nd</sup> tranche of grant amounting to Rs. 33 crore was released for deployment of 150 Electric buses in the city of Pune.
  - ii. 3<sup>rd</sup> tranche of grant amounting to Rs. 1.10 crore was released after successful completion of 06 months for 5 Electric buses in the state of Goa.
  - iii. 2<sup>nd</sup> & 3<sup>rd</sup> tranche of grant amounting to Rs. 4.32 crore was released for deployment of 14 Electric buses & after successful completion of 06 months for 10 Electric buses respectively in the city of Silvassa.

- 6. BHEL received 'Letter of Appreciation' from the Indian Navy for supplying, installing, and commissioning the Integrated Platform Management System (IPMS), one of the largest systems onboard, towards timely commissioning of the indigenous aircraft carrier INS Vikrant.
