DEPARTMENT OF HEAVY INDUSTRY

MONTHLY SUMMARY FOR THE MONTH OF SEPTEMBER, 2015

- i. **Indian Delegation to the 66th IAA International Motor Show at Frankfurt, Germany:**
Hon'ble Minister of Heavy Industries & Public Enterprises (HI&PE) Shri Anant G. Geete led the Indian Delegation to the 66th IAA International Motor Show at Frankfurt, Germany during 16-19 September 2015. During the visit, MHI attended the inaugural event of IAA by Chancellor Ms. Angela Merkel, met German Federal Minister for Transport and Digital Infrastructure Mr. Alexander Dobrindt and inaugurated the 10th India Day event. He met a large number of other stake-holders from Indian and German automobile, auto-component and transport logistic industries who are planning investment in India. He also visited key technology stalls at the Motor Show and held in depth discussions for facilitation of greater transfer of technology and enhanced investments in the auto sector in India, particularly in the fields of electric mobility, automotive electronics, safety devices, ITS.
- ii. **Demand Incentive Delivery Mechanism (DIDM):** An E-platform for Demand Incentive Delivery Mechanism (DIDM) was launched by the Hon'ble Minister for HI&PE Shri Anant G. Geete on 3rd September, 2015 at the Annual Convention of Automotive Component Manufacturers Association of India (ACMA) in New Delhi. This E-Platform would facilitate online submission of claims as well as clearance of incentives for sale of hybrid and electric vehicles on a monthly basis, without any delays, under the initiative for Faster Adoption and Manufacturing of Electric Vehicles in India (FAME-India) launched by the Government under the National Mission on Electric Mobility in April this year.
- iii. **Compliance of emission norms by VW for their various diesel car models:**
Following the irregularities detected by the regulatory agencies in USA regarding compliance of emission norms by VW for their various diesel car models in these countries, DHI has directed Automotive Research Association of India (ARAI) to cause an in-depth enquiry and testing of VW vehicles in question in India with a view to ascertain any violation of emission norms by VW India in their car models sold in the country. ARAI has already initiated the test procedures and the final report is expected by the end of October 2015.
- iv. **Annual Convention of Society of Indian Automobile Manufacturers(SIAM):**
Annual Convention of Society of Indian Automobile Manufacturers (SIAM) was held on 2nd September 2015 at New Delhi. A curtain raiser for Automotive Mission Plan -II (2016-2026) was released.

- v. **Expenditure Finance Committee (EFC) meeting on RCE-II of NATRiP:**
A meeting of Expenditure Finance Committee (EFC) on RCE-II of NATRiP was held under the Chairmanship of Secretary (Expenditure) on 16th September, 2015. The EFC considered the DHI proposal and recommended the proposal for acceptance with certain conditionalities.
- vi. **Inauguration of the new Automatic SPV Module Manufacturing Line and 100 KW Rooftop SPV Power Plant of REIL:** Hon'ble Minister of Heavy Industries & Public Enterprises inaugurated the new Automatic SPV Module Manufacturing Line and 100 KW Rooftop SPV Power Plant of Rajasthan Electronics & Instruments Limited (REIL) in Jaipur on 11th September, 2015. The Automatic SPV Module Manufacturing Line is setup to enhance the manufacturing capacity of REIL in line with "Make in India" Mission. During the visit, Hon'ble Union Minister also met Hon'ble Chief Minister, Government of Rajasthan wherein state government expressed their desire for help to setup solar power plants including manufacturing of equipments for the same.
- vii. **Meeting of DHI -CII Joint Task Force:**
The Second Meeting of the Department of Heavy Industry (DHI) - Confederation of Indian Industries (CII) Joint Task Force was held on 1st September, 2015 under the Chairmanship of Secretary, Heavy Industry to deliberate on the draft base paper on the National Policy on Capital Goods. The focus was to evolve a Policy that should clearly outline the range of measures that need to be fast tracked for developing a competitive industry that can match global standards. The Draft paper underlined the potential objectives for the Capital Goods Industry i.e, to achieve a quantum jump in the domestic as well as overseas market in the capital goods sector. We are working to give a final shape to the Policy after consultations with stakeholder Ministries.
- viii. **Free Trade Agreements (FTA) meeting held in DHI:**
As part of our outreach to Industry, a meeting was held in the Department on 29th September, 2015 on the subject of Free Trade Agreements (FTA) with the countries of Regional Comprehensive Economic Partnership (RCEP) which include 10 ASEAN countries, China, Japan, South Korea, Australia and New Zealand. The Meeting was attended by the representatives of the concerned industry associations viz. SIAM, ACMA, PMMAI, IMTMA, IEEMA, TMMA etc. The Industries Association were requested to identify and submit a list of inputs for inclusion in the FTA to promote the capital goods sector in the country.
- ix. **Implementation of the Indian Electrical Equipment Industry Mission Plan 2012-22:** In order to provide impetus to the heavy electrical and allied industrial sector in the changing business environs and technology and to review and monitor the implementation of the recommendations of the Indian Electrical Equipment Industry Mission Plan 2012-22, the

Department of Heavy Industry has constituted a Development Council for Heavy Electrical and Allied Industries with effect from 15th September, 2015 for a period of two years under the provisions of the Industrial (Development and Regulation) Act, 1951.

- x. **Annual Conference of Executive Council of Indian Electrical and Electronics Manufacturers Association (IEEMA):** The Annual Conference of the Executive Council of Indian Electrical and Electronics Manufacturers Association (IEEMA) was inaugurated by the Hon'ble Minister on 25th September, 2015 at Mumbai. IEEMA Executive Council shared the growth path of the Sector under "Make in India" initiatives of the Government and sought hand holding support from the Government in the field of testing facilities of electrical and electronic equipment in country spread widely over the geographical area of the country. The Department of Heavy Industry is examining this and would come out with a holistic scheme in future.
- xi. **National Meet on Promoting Use of Space Technology in Governance and Development:** Secretary, HI participated in the National Meet on Promoting Use of Space Technology in Governance and Development held on 7th September, 2015 in Vigyan Bhawan, New Delhi. Amongst various suggested areas of technology collaboration, Bharat Heavy Electricals Limited (BHEL), a Maharatna CPSE under this Department would be working with ISRO for development of next generation ceramic Thermal Barrier Coating (TBC) for gas turbine applications that can withstand the temperature of 1200 ° to 1400 ° Celsius. A special cell has been constituted in this Department to explore and follow up the areas of space applications.
- xii. **WIN India 2015 Exhibition to be held in New Delhi in December, 2015:**
A Press Conference was held in New Delhi on 24th September, 2015 to announce the holding of WIN India 2015 Exhibition to be held in New Delhi from 9th to 11th December, 2015. The Department is supporting HMF India —a subsidiary of Deutsche Messe to organise the technology show. This is a mini version of Hannover Messe Trade Fair held in April 2015, in which India was the partner country, and was inaugurated jointly by the Hon'ble Prime Minister of India and Chancellor of Germany. More than 400 global companies will show latest manufacturing technologies required for "Make in India". DHI will show case a theme pavilion and with FICCI organise a number of technology networking round-tables / meetings.
- xiii. **Indo-German High Technology Partnership Group meeting in New Delhi at Foreign Secretary level:** Indo-German High Technology Partnership Group met in New Delhi at Foreign Secretary level. DHI made two presentations on 14th September, 2015 in Ministry of External Affairs. The first one was on status and prospect of Advanced Manufacturing

Technologies in India and the second was on Road Map to develop the industry in India viz. Germans' role & opportunities. DHI also organised an industry audience for workshop on provisions of German Export Control policies & procedures. Through the industry, DHI called for German co-operation in spreading awareness on their export control mechanism in Indian industry particularly for dual use machine tools.

xiv. Bharat Heavy Electricals Limited (BHEL)- achievements in September, 2015:

Bharat Heavy Electricals Limited (BHEL) has achieved a total order booking of Rs.21,886 Crore upto September, 2015 in the current financial year (as against Rs. 13,672 Crore upto August, 2014 during the last financial year). This includes Rs. 977 Crore orders booked during the month of September, 2015

xv. Annual Conference of all CMDs of CPSEs under DHI:
Department of Heavy Industry convened an Annual Conference of all CMDs of CPSEs under DHI on 21st September, 2015 to discuss and work out synergies between the various CPSE's. The discussions were fruitful.
