MONTHLY SUMMARY OFSIGNIFICANT ACTIVITIES FOR SEPTEMBER, 2017

This has reference to Cabinet Secretariats' DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of September, 2017 in the Department of Heavy Industry (DHI).

- 1. Two meetings of IMG pertaining to Auto Policy were held wherein issues regarding the arbitration case on the fiscal incentives under the MoU between Government of Tamil Nadu and Nissan Motors were discussed. The matter of appointing Presiding Arbitrator was followed up and attempts were made to use diplomatic and other channels to reach amicable settlement through the State Govt. of Tamil Nadu.
- 2. Hon'ble Minister Shri Anant Geete visited Frankfurt, Germany to attend the 67th International Motors Show (IAA) from 14-15 September, 2017. JS (HE&MT) also visited Germany from 19-22 September, 2017 to study the German Industry 4.0 Platform. This was as a part of follow up action under the joint declaration by India and Germany.
- 3. With reference to the exercise being formulated by the Department of Public Enterprises (DPE) to redefine the role and manufacturing of CPSEs which would culminate as CPSE Conclave to be addressed by Hon'ble Prime Minister of India, a Brainstorming Session with the Government nominee Directors of CPSEs included in Group-IX 'Heavy Engineering & Medium Engineering' was organized on 21st September, 2017.
- 4. A Brainstorming Session under the chairmanship of Dr V K Saraswet, Member, NITI Aayog was held on 27th September, 2017 at Central Manufacturing Technology Institute, Bangalore to deliberate on the transformation of CMTI into a "National Smart Manufacturing Design Innovation Centre".
- 5. Bharat Heavy Electricals Limited (BHEL) held its 53rd Annual General Meeting on 22nd September, 2017 in New Delhi. During the Financial Year 2016-17, BHEL recorded a turnover of Rs.28,840 Crore, around 11% over the previous year and a Profit Before Tax (PBT) of Rs.628 Crore, compared to a loss of Rs.1,164 Crore in the previous fiscal. Net Profit (PAT) stood at Rs.496 Crore, against a net loss of Rs.710 Crore in the previous year. The Company announced a final dividend of Rs.39% in addition to the interim dividend of 40%, taking the total dividend to 79% for the fiscal 2016-17. It also announced issue of bonus shares in the ratio of 1 bonus share for every 2 existing shares.
- 6. BHEL has won 15 Vishwakarma Rashtriya Puraskar for 2015 and also won 6 National Safety Awards. It also received Excellence Awards, 2016 for R&D, Technology Development & Innovation, HR Management Excellence and contribution of Women in PSEs in the Maharatna & Navratna CPSEs category by the Indian Chamber of Commerce.
