

TENDER NOTICE

Subject: Contract for upholstery of sofa chair etc., in Department of Heavy Industry.

The undersigned is directed to invite sealed quotations for award of contract for upholstery of sofa chairs etc. in the Department of Heavy Industry as given at Annexure. The tender offer in sealed covers should be submitted to the undersigned on or before 3.30 p.m. on 22/02/2016 in Room No.15, Udyog Bhavan. The tender will be opened at 4.00 p.m. on the same day. The earnest money deposit of Rs.5,000/- (Rupees five thousand only) in the form of DD/FDR in favour of DDO, Department of Heavy Industry, New Delhi may be enclosed with the quotations. The terms and conditions are as under:-

1. The contract will be initially for a period of one year which can be extended upto three years if the services provided by the firm are found satisfactory. This Department shall however, have the right to terminate the contract at any time without assigning any reasons therefor.
2. The contractor or his representative shall have to visit GA Section Room No.15, Udyog Bhavan, New Delhi on all working days for collecting orders.
3. No advance payment will be made in any case.
4. No request of escalation of rates would be entertained after approval of rates.
5. All the bills submitted by the successful tenderer would accompany with the work vouchers duly signed by the concerned officers/officials.
6. The quotation without EMD will not be entertained.
7. The quotation/rate with condition will not be entertained. Cutting/overwriting, if any should be countersigned/attested. If tax is required to be paid by the Department, it should be mentioned separately and clearly in the quotation. This should not be added to the basic rates but shown separately failing which no amount towards any tax will be paid.
8. The successful bidder will have to deposit Rs.10,000/- (Rupees ten thousand only) in advance as security deposit in the form of DD/FDR for a period of not less than one and half years in favour of DDO, DHI to be retained during the currency of the contract. The security deposit will be refundable only after successful completion of the contract. The security money will be forfeited if during the period of contract, the services of the contractor are found to be unsatisfactory in any respect or in the event of breach of contract by Contractor before the date of completion of the Contract.
9. If the work of tenderers is found unsatisfactory this Department at any time can terminate the contract without assigning any reasons therefore. This Department also reserves the right to reject any quotations(s) in full or in part without assigning any reasons therefor.


