With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of September, 2023 are highlighted:

- दिनांक 14 सितम्बर, 2023 को हिंदी दिवस के अवसर पर माननीय भारी उद्योग मंत्री डॉ. महेंद्र नाथ पाण्डेय द्वारा झांसी इकाई में मंत्रालय के अधीन उपक्रमों के 25 नवीन और नवीनीकृत पुस्तकालयों का उद्घाटन किया गया। इस अवसर पर बीएचईएल की इकाइयो में 75,000 पौधे लगाने का लक्ष्य पूरा करने के उत्सव के रूप में 'हरित बीएचईएल' अवधारणा पत्र का विमोचन भी भारी उद्योग मंत्री के कर कमलों से किया गया।
- 2. During the preparatory phase of Special Campaign 3.0 from 15<sup>th</sup> September, 2023 to 30<sup>th</sup> September, 2023, MHI alongwith its Central Public Sector Enterprises (CPSEs) and Autonomous Bodies (ABs) has identified more than 250 sites across the country for cleanliness during the main phase of Special Campaign 3.0 from 2<sup>nd</sup> October, 2023 to 31<sup>st</sup> October, 2023. In addition, 5.6 Lakh Sq. ft. space is anticipated to be freed after disposal of scrap and other redundant material. 65,944 physical files have been identified for review and 33,789 physical files will be weeded out. 5,017 e-files have also been identified for closure and more than 170 Tweets have been posted on 'X' (erstwhile Twitter) by the official social media handle of MHI and its CPSEs /ABs.
- 3. Under 'Swachhata Hi Sewa' Campaign, I administered the Swachhata Pledge on 29<sup>th</sup> September, 2023 to all officials of my Ministry to create a clean and garbage free India.
- 4. A meeting was held on 11<sup>th</sup> September, 2023 with PLI-ACC beneficiary, M/s. Reliance New Energy Battery Storage Ltd. to review the progress under the scheme.
- 5. Demand Incentive of Rs.302 crores (approx.) was released to M/s. IFCI Ltd. for further disbursement to various Original Equipment Manufacturers (OEMs) under FAME-India Scheme Phase-II for e-2W, e-3W and e-4Ws.
- 6. Stakeholders discussion / meeting was held on 4<sup>th</sup> September, 2023 on Draft SOP for incentive claim processing under PLI Scheme for Automobile & Auto Components to seek their comments.
- 7. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In September, 2023, 433 GST Concession Certificates were issued.
- 8. 14 townships of BHEL spread across the nation have been certified as Single-use Plastic Free Zones for the last 3 years as a result of the various initiatives undertaken by BHEL under GoI's 'Swachh Bharat Abhiyan'.
- Commercial Operation Declaration (COD) of Unit#1 (BHEL Scope SG Package) of 2x800 MW of NTPC Telangana (Karimnagar) was successfully carried out on 28.09.2023
