With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of November, 2023 are highlighted:

- 1. Dr. Mahendra Nath Pandey, Hon'ble Minister of Heavy Industries chaired a meeting on "मंथन-लोकल से ग्लोबल भारत-विनिर्माण से आत्मनिर्भरता," on November 22, 2023, at Yashobhoomi Convention Centre, New Delhi. The event was attended by various stakeholders and industry associations representing the automotive and capital goods sectors to review strategies to curb imports, enhance localization, and boost exports. The event had a special focus on understanding the opportunities available to enhance the pace of localization.
- 2. (a) Dr. Mahendra Nath Pandey, Hon'ble Union Minister for Heavy Industries, in the presence of senior officials from MHI and BHEL inaugurated "BHEL SAMVAAD 3.0 अनुसन्धान से आत्मनिर्भरता की ओर, BHEL की एक और पहल" on 09.11.2023 organized by BHEL with an aim to promote indigenization through discussions with domestic business partners, industry associations, academia, and research institutes. Hon'ble Minister unveiled BHEL's R&D compendium titled 'Anusandhan se Aatmanirbharta'.
- 2. (b) During the program, Hon'ble Minister launched MHI's 'Annual Capacity Building Plan (ACBP)' for 2023-24. The ACBP outlines key strategic areas and focused capacity-building initiatives within the Ministry to enhance capability across all levels and achieve maximum governance, aligning with the PM's vision of Mission Karmayogi.
- 3. Hon'ble Union Minister for Heavy Industries chaired meeting on 07.11.2023 with Auto Industry leaders on global competitiveness and export potential for Indian Auto Industry.
- 4. Hon'ble Minister of Heavy Industries held a meeting on 07.11.2023 with selected beneficiary firms namely, ACC Energy Storage Pvt. Ltd. and Ola Cell Technologies Pvt. Ltd. under PLI-ACC scheme for reviewing the progress of their projects.
- 5. I reviewed the performance of Autonomous Bodies under MHI on 29<sup>th</sup> and 30<sup>th</sup> November, to identify way forward for their better performance.
- 6. Demand Incentive of Rs. 253.00 Cr. (approx.) was released to M/s. IFCI Limited for further disbursement to various Original Equipment Manufacturers (OEMs) in the month of November, 2023 under FAME-India Scheme Phase-II for e-2W, e-3W and e-4W.
- 7. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In November 2023, a total of 323 GST Concession Certificates were issued.

- 8. BHEL has signed a Memorandum of Understanding (MoU) with 'Umoe Advanced Composites AS', Norway. The MoU aims to explore technology transfer for the establishment of Type-IV Composite Cylinders (Hydrogen/CNG) manufacturing facility at BHEL.
- 9. BHEL has signed a contract of Rs. 2956.89 Crore with the Ministry of Defence (MoD) for the supply of 16 Upgraded Super Rapid Gun Mounts (SRGM). These will be installed on both in-service and newly built ships of the Indian Navy and will be manufactured at the Haridwar unit.
