**2711. SHRI GUMAN SINGH DAMOR:**

Will the Minister of HEAVY INDUSTRIES भारी उद्योग मंत्री be pleased to state:

- (a) the number of Central Public Sector Enterprises (CPSEs) under the Ministry;
- (b) the number of undertakings which are functional and numbers of those which have been closed along with the reasons therefor;
- (c) the details of the profit/ loss made by these CPSEs every year;
- (d) the number of CPSEs which have subsidiaries and out of these the number of subsidiaries which are operational and the number which have been closed along with the reasons therefor;
- (e) the details of the number of subsidiaries which are making profit out of the functional subsidiaries along with the number of subsidiaries which are in loss;
- (f) the number of enterprises/ companies which are engaged in manufacturing of electric four wheelers; and
- (g) the quantum of noise and air pollution likely to be reduced by the operation of an electric four wheeler and the quantum of likely reduction in crude oil imports as result thereof?

**(g):** As informed by NITI Aayog, an electric four wheeler during its operation is Zero Pollution (tail pipe emission) and very minimal noise. It does not require any gasoline based product (diesel, petrol and CNG) in its operation.
