With reference to D.O. letter No.502/1/2/2014-CA-V dated 5th August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of December, 2023 are highlighted:

- 1. MHI showcased its accomplishments of Special Campaign 3.0 at Dr. Ambedkar International Centre, New Delhi, on 19th December 2023 during the inaugural function of Good Governance Week 2023 Celebrations which were inaugurated by Dr. Jitendra Singh, Minister of State for Personnel, Public Grievances and Pensions.
- 2. MHI held a meeting with officials of Ministry of New & Renewable Energy, Ministry of Power, NITI Aayog and Central Electricity Authority on 12th December, 2023 to discuss the way forward on EGoS recommendations given in the meeting on 2nd 3rd November, 2023 for the Round-2 bidding for 20GWh capacity under PLI-ACC Scheme.
- 3. Team comprising members of MHI, PMA and EIL visited the plant of Ola Cell Technologies Pvt. Ltd., one of the selected beneficiary firms in PLI-ACC Scheme, at Krishnagiri, Tamil Nadu on 12th December, 2023 and R&D site at Bengaluru on 15th December, 2023 to review the ground status for setting up of manufacturing facility.
- 4. A meeting to review the status of Advanced Automotive Technology (AAT)/ Domestic Value Addition (DVA) certification applications with the Testing Agencies and the issues faced by the applicants, was held on 22nd December, 2023.
- 5. Gazette notifications for amendment to the notification of PLI Scheme for Automobile & Auto Components and its guidelines dated 23rd September, 2021, were issued on 29th December, 2023 extending the tenure of the scheme by one year i.e. up to FY 2027-28.
- 6. Demand Incentive of Rs.82.65 crore was released to M/s. IFCI Ltd. for further disbursement to various Original Equipment Manufacturers (OEMs) in the month of December, 2023.
- 7. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In December, 2023, a total of 491 GST Concession Certificates were issued.
- 8. Quality Control Amendment Order on Automobile Wheel Rim Component was issued on 19th December, 2023. This will help to curb imports of automobile wheel rims in India and promote 'Make in India'. Certain exemptions have been provided for imports of certain quantities for repairs or after sales service etc.

- 9. INS Imphal, a Vishakhapatnam class Destroyer equipped with Bharat Heavy Electricals Ltd. (BHEL)'s Super Rapid Gun Mount (SRGM) was commissioned into the Indian Navy on 26th December 2023 in the presence of Shri Rajnath Singh, Hon'ble Defence Minister.
- 10. BHEL signed MoUs with:
 - Central Manufacturing Technology Institute (CMTI), Bengaluru on 14th December, 2023 for joint development of Electrolysers and Industry 4.0 solutions.
 - JSC Rosoboronexport, Russia on 19th December, 2023 for maintenance and modernisation of T-72 and T-90 tanks.
