Respected Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated 5th August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of January, 2024 are highlighted:

1. Ministry of Heavy Industries organised a PLI-Auto Conclave under chairmanship of Dr. Mahendra Nath Pandey, Minister of Heavy Industries on 16.01.2024 at Bharat Mandapam, New Delhi, highlighting the salient features of the PLI Scheme for Automobile and Auto Component Industry and undertaking stakeholder consultation. Shri Krishan Pal Gurjar, Minister of State for Heavy Industries and Power was also present during the PLI Auto Conclave. The vehicles which have been approved under the scheme were also displayed during the event. In the conclave, Hon'ble Minister urged the stake holders for increasing indigenization in Auto Industry paving the path for "Aatmanirbhar Bharat".
2. Dr. Mahendra Nath Pandey, Minister of Heavy Industries, inaugurated the newly constructed 'BHEL Sadan' at Noida, Uttar Pradesh on the occasion of 'BHEL Day', in the presence of Shri Krishan Pal Gurjar, Hon'ble Minister of State for Heavy Industries and Power, senior officials of MHI and BHEL. On this occasion, Hon'ble Minister urged BHEL to continue with their diversification efforts for better services to the nation.
3. Under PLI-Advanced Chemistry Cell (ACC) Scheme, Request for Proposal (RFP) for bidding of 10 GWh ACC (application agnostic), has been released on 24.01.2024 on CPPP portal. Pre-bid meeting is scheduled to be held on 12.02.2024.
4. Ministry of Heavy Industries (MHI), participated in the 'Aatmanirbhar Bharat Utsav' organised at Bharat Mandapam, Pragati Maidan, New Delhi from 3rd to 10th January 2024 showcasing its capabilities and technological prowess in core sectors of Automobiles, EVs, Power Sector and Diversification efforts.
5. Demand Incentive of Rs. 78.73 Cr. was released to M/s. IFCI Limited for further disbursement to various Original Equipment Manufacturers (OEMs) in the month of January, 2024 under FAME-India Scheme Phase-II for e-2W, e-3W and e-4Ws.

6. Under PLI-Auto & Auto Components Scheme, Stakeholder Consultation meeting on SOP Claim Verification was held on 30.01.2024 in this Ministry.

7. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In January 2024, a total of **183** GST Concession Certificates were issued.

8. Cabinet has approved enhancement of equity investment beyond 30% by Coal India Ltd. to form two Joint Ventures (JV) companies with Bharat Heavy Electricals Ltd. (BHEL) and Gas Authority of India Ltd (GAIL). This will expedite JV formation between BHEL and Coal India Limited for a coal to 2000 TPD Ammonium Nitrate Plant.
