Moreover, most of the projects sites are within industrial plants where the clients also have their own safety regulations and norms which have to be adhered to by all contractors. Accordingly, all the equipment, fixtures, etc. are routinely inspected for fitness and adequate Personnel Protective Equipment (PPE) are provided to all personnel at the sites. Workmen are also given regular Safety Toolbox talks to encourage observance of safety measures. With all these precautions number of accidents have been reduced as compared to earlier years. However, stray accidents still happen at the project sites in spite of all precautionary measures incident, the reason for the same is investigated and conveyed to all personnel, such that safety measures are sincerely and strictly followed to prevent such mishaps in the future. So far there is no case where action against officer is required.
