## Respected Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of May, 2024 are highlighted:

- 1. Department of Expenditure reported that as on 21.05.2024, 964 claims out of total 4314 Claims pertaining to CPSEs of this Ministry were pending for settlement under Vivad se Vishwas I. All the pending claims were settled and MHI reported zero pendency in the review meeting held on 31.05.2024 under the chairmanship of Finance Secretary.
- 2. A meeting on "Action Plan for National Capital Goods Policy 2025" was held on 24.05.2024 with representatives of CII and FICCI including members from their concerned knowledge partners to initiate the process of wider stakeholder consultations.
- 3. Under PLI-Auto Scheme, a workshop was organized on 17.05.2024 to assist the approved applicants with any queries/ issues pertaining to the scheme.
- 4. MHI organized a workshop on 22.05.2024 regarding the testing of Advanced Chemistry Cells, with BIS-identified laboratories, to assess the readiness of laboratories for testing ACCs under IS 17882 and provide necessary handholding for early certification.
- 5. MHI conducted quarterly review meeting on 08.05.2024 with all three beneficiary firms under PLI ACC Scheme to assess the progress made and to assist the approved applicants with any queries/ issues pertaining to the scheme.
- 6. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In May 2024, a total of 334 GST Concession Certificates were issued.
- 7. BHEL entered into a Technology Transfer Agreement with Bhabha Atomic Research Centre (BARC) on 27.05.2024 for 50 kW alkaline electrolyser system for Hydrogen production. This will enable BHEL to participate in SIGHT Program for Tranche II of Hydrogen Electrolyser Manufacturing under the National Green Hydrogen Mission launched by MNRE.
- 8. A Joint Venture (JV) has been incorporated as "Bharat Coal Gasification and Chemicals Limited" on 28.05.2024 with the objective to engage into the business of coal gasification to produce Syn-Gas, Ammonia & Nitric acid as intermediate products and Ammonium Nitrate as end product. The JV is with Coal India Limited (CIL) in which CIL holds 51% and BHEL holds 49% equity.
