**Fluid Control Research Institute (FCRI)**, is an autonomous R&D Institute under Govt. of India, Ministry of Heavy Industries dedicated to the Nation in 1989. The main objective of the Institute is to extend technical services to all flow product manufacturers and users by way of testing/calibration, R&D and training.

**I. Job Profile:**

The Director is the Chief Executive of the Institute empowered by the Governing Council to manage the day-to-day technical and administrative activities of the Institute and is responsible for the formulation, development and implementation of the institute's technology programs.

**II. Qualification**

**Essential:** Post Graduate in any branch of Engineering from a recognized University/ Institution.

**Desirable:** Ph.D. in any Engineering Discipline or PG in Management Sciences.

**III. Experience**

**Essential:** Must have at least 20 years' experience in any industry or institute or organization, out of which last 5 years' experience should be at senior management level. Must have experience in dealing with technical & administrative matters, financial control and human resources management.

**Desirable:** Five years' experience in fluid flow domain.

**IV. Age limit**

**Maximum Age:** 55 years for external candidates and 58 years for internal candidates.

**Cut-Off Date:** The cut-off date for deciding eligibility shall be the closing date for receipt of applications.

**V. Pay & Allowances**

The Post is in the **Pay Level 14 (Rs 1,44,200 - Rs 2,18,200)** of 7th CPC plus allowances as admissible.

**VI. Method of Recruitment**

- i Mode of recruitment is 'Selection'. The candidate for this post shall be selected by a Search Cum Selection Committee constituted in terms of DoPT OM dated 31.08.2022, as amended from time to time.
- ii The appointment to the post will be for 5 years' tenure or till the date of superannuation, whichever is earlier, with the approval of ACC. Further, the tenure is extendable up to 5 years or till the date of superannuation whichever is earlier, in terms of DoPT OM dated 31.08.2022, as amended from time to time.
- iii Officers from the Central/State Government/ PSUs, Defence/ Autonomous Research Institutions holding analogous/ equivalent post or with 2 years' regular service in post carrying pay level 13A or with 3 years' regular service in post carrying a pay level of 13 shall be eligible.
- iv Central Government officers including those of the Armed Forces of the Union and the All India Services and officers from Public Sector Undertakings, Defence/

Autonomous. Research Institutions will be eligible for consideration only on immediate absorption basis for 5 years' tenure or till the date of superannuation, whichever is earlier.

**VII. To Apply:**
