Kindly refer to your D.O. letter No. 1/50/3/2024-Cab. dated 24thOctober, 2024. So far as Ministry of Heavy Industries is concerned, the report for the month of June, 2025 is as follows:

I would like to bring the following to your notice for the month of June, 2025:-

- a. The detailed guidelines of the Scheme to Promote Manufacturing of Electric Passenger Cars in India (SPMEPCI) were notified on 2nd June, 2025 and the Scheme's portal (https://spmepci.heavyindustries.gov.in) was launched by Hon'ble Minister (Heavy Industries) on 24th June, 2025. The application window for the SPMEPCI is open till 21st October, 2025.
- b. The progress of PLI-ACC Scheme was reviewed by the Hon'ble Minister (Heavy Industries) on 3rd June, 2025 to understand the issues being faced by the beneficiaries in installation and commissioning of manufacturing facilities.
- c. As a part of the 11th International Yoga Day 2025 themed 'Yoga for One Earth, One Health' celebrations, MHI in association with BHEL, organized a Common Yoga Protocol demonstration at BHEL, Noida premises on 21st June, 2025. I alongwith senior officers / officials of MHI and senior management of all CPSEs of MHI in Delhi also participated in the event.
- d. Under the PM e-Bus Sewa Payment Security Mechanism (PSM) Scheme, Direct Debit Mandate (DDM) was signed by the State Government of Andhra Pradesh, Madhya Pradesh and Meghalaya in the month of June, 2025. Hence, so far 8 States (Karnataka, Telangana, Gujarat, Rajasthan, Punjab, Andhra Pradesh, Madhya Pradesh and Meghalaya) have submitted the DDM to RBI out of which RBI's acknowledgement is received for the 4 States (Karnataka, Telangana, Gujarat and Rajasthan).

- e. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In June 2025, a total of 454 GST concession certificates were issued.
- f. As per DARPG's monthly report for May 2025 titled 'Secretariat Reforms', MHI secured 3rd position across all Ministries/Departments for revenue earned to the tune of Rs.3.82 cr. from scrap disposal and space freed i.e. 24257 sq ft.
- g. BHEL received Appreciation Letter from North Refineries Company (NRC), Ministry of Oil, Iraq for providing online training on Centrifugal Compressor to the their employees.
