I would like to bring the following to your notice for the month of September, 2025:-

- The Ministry and its CPSEs/ Autonomous Bodies actively participated in the Swachhta Hi Sewa Campaign during 17th September to 2nd October 2025, focusing on mass cleanliness drives and public awareness activities with emphasis on plastic waste management and community involvement. Under the campaign, a total of 71 Cleanliness Target Units (CTUs) have been transformed.
- Under the Swasth Nari, Sashakt Pariwar Abhiyaan during 17th September to 2nd October 2025, the CPSEs and Autonomous Bodies under this Ministry organized health awareness camps, menstrual hygiene drives, and nutrition programs for women. Under the campaign a total footfall of 4,227 was recorded.

- The Ministry of Heavy Industry has submitted an EFC note on the scheme to promote "Sintered Rare Earth Permanent Magnet (REPM) Manufacturing in India" to Department of Expenditure (DoE) on 15th September, 2025 for appraisal.
- A Meeting of High-Level Committee for Viksit Bharat (HLC-VB) with this Ministry was held on 11th September, 2025 at NITI Aayog followed by review meeting held on 25th September, 2025. A report by the HLC has since been received with certain recommendations. The action on the same has been initiated for timely compliance.
- Under the PLI-Auto Scheme, Domestic Value Addition Certificates were issued to 1 Champion OEMs for 1 product (variants) & 1 Component Champions for 1 product (variants) during the month of September 2025. So far, till 30 September, 2025, Domestic Value Addition Certificates issued to 8 Champion OEMs for 87 products (variants) & 10 Component Champions for 36 products (variants) under the Scheme.

- Under the PM e-Bus Sewa-Payment Security Mechanism (PSM) Scheme, the State Government of Odisha and UT of Jammu & Kashmir have submitted the Direct Debit Mandate (DDM) to RBI. Hence, as on 30th September 2025, total 12 States/UT (Gujarat, Karnataka, Rajasthan, Punjab, Telangana, Andhra Pradesh, Madhya Pradesh, Meghalaya, Maharashtra, Uttarakhand, Odisha and Jammu & Kashmir) have submitted the Direct Debit Mandate (DDM) to RBI.
- BHEL made entry into the critical railway safety segment by getting the maiden order for the KAVACH system from Indian Railways. The order is for design, development and installation of on-board KAVACH equipment in locomotives and at trackside locations on 36 Km section of the South Western Railways in Bengaluru.
